NOTICE INVITING OBJECTIONS

Whereas the Departmental Building housing the headquarters of various Engineering Departments inter alia the shopping complex consisting of 40 number of shops from serial No. 74 A to 112 belonging to Govt. Central Market Handicrafts Department were gutted in devastating fire episode on 11.09.2010.

Whereas 19 shops were gutted and 21 shops suffered partial damage in the fire episode.

Whereas the Government decided to construct a new building at the site housing a shopping complex for rehabilitation of the affected stall holders and others through Economic Reconstruction Agency (ERA).

Whereas towards facilitation of construction of the rehabilitation complex, possession of these affected stalls was received by the department from the de-facto possessors/allottees in whose name the department routinely received the usual rentals and in lieu of the same, possession of pre-fabricated stalls (constructed in the lawns of the Government Central Market Srinagar) was handed over as an interim measure by the department till their final rehabilitation in the Rehabilitation Complex to be built by ERA.

Whereas, upon completion of the Rehabilitation Complex, the Forty (40) demarcated stalls/shops (practically 36 as per physical status) were allotted by ERA to the department for housing of the displaced stallholders/shopkeepers.

Whereas the proposal for bifurcation of all the big sized corner shops submitted by the Central Market Shopkeepers Association was agreed to by the Government so as to accommodate all shopkeepers/allotees/tenants.

Whereas the possession of the shops is required to be handed over to genuine titleholders, stall holders/ present occupants by conducting a draw of lots in presence of competent committee.

Whereas before such transfer of possession is effected, it has been decided to invite objections (if any) from general public/concerned allottees/ any other person having interest against handing over of possession of the stalls/shops to the concerned allottees/present occupants.

Whereas as per the records available the particulars of below mentioned persons who have been allotted the shops/ stalls originally together with the particulars of the present occupants of the stalls/ shops as per records of the office of the Central Market is hereby published for general information of the public and for submission of objections if any regarding allotment of newly constructed rehabilitation shops in favour of the present occupants.
