The Heads of the Institutions shall send the list of candidates admitted in different disciplines and short fall, if any, along with Roll Nos. and names of candidates who have not taken admission on 23<sup>rd</sup> of September, 2015 by 5:00 P.M., positively to BOPEE office, Srinagar / Jammu by fax., email and by hand also.

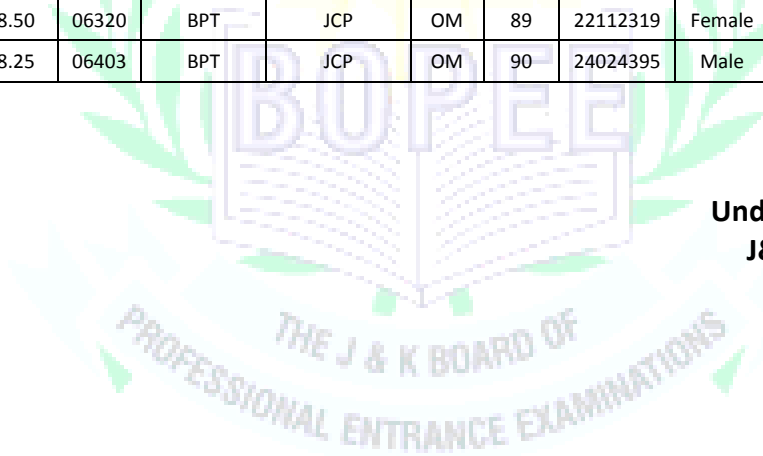
