The above named appointee(s) shall be governed by the new Pension Scheme as Notified Vide SRO 400 of 2009 dated: 24-12-2009 and SRO 202 Dated: 30-06-2015.

- (a). During the period of five years, the appointee(s) shall be entitles to the minimum of scale of pay along with the grade pay applicable to the post against which he/ she is appointed.
- (b). The appointee(s) shall after completion of five years period on probation be entitled to fixation of pay in the time-scale of pay applicable to the post against which he/ she is appointed.
- (c). The appointment(s) shall be entitled to Annual increments, Dearness Allowances, House Rent Allowances and City Compensatory Allowance after successful completion of their five years service on consolidated salary.

The appointee (s) shall report to Directorate of Family Welfare MCH & Immunization J&K, Near Sanik School Nagrota, Jammu, within 21 days from the date of issuance of this appointment order along with following certificates in original. In case they fails to report within the stipulated period, their appointment shall be deemed to have been cancelled ab-initio without any further notice:-

- The appointee shall give an undertaking in the shape of affidavit to the office that in case adverse report about their character and antecedents is received from CID/other agencies, the candidate shall have no right to claim his appointment as EMPHW.

The appointment of the above candidates as FMPHW in Family Welfare Department shall further be subject to the following conditions:-

- The appointment in District / Divisional cadre is non-transferable from one District/ Division cadre to another District/ Division Cadre.
- The appointee shall be on probation for a period of five years and after completion of five years the service shall be declared as permanent in accordance with the relevant recruitment rules governing the post/ service to which he/ she has been appointed.
- The appointee have to necessarily work for a period of five years on the post against which appointed and such appointee shall not be eligible for transfer for whatsoever iii. reason during the temporary service of five years.
- iv. The salary of the appointee(s) shall not be drawn and disbursed to them till geniuses of their character and antecedents are received from CID and other agencies.
- If in verification, character and antecedents of the appointee are found adverse or the certificates produced by the appointee are proved fake or forged, her appointment shall be deemed to have been cancelled ab-initio without any further notice.
