**Reference:** Government Order No : 52-SW of 2018, Dated 06/02/2018

**Subject:** Constitution of Child Welfare Committees of 22 Districts of Jammu and Kashmir.

Vide Notice No. 15 of SMD of 2017 Dated 18/04/2017 read with re-advertisement DIP/K-2913 dated 26/07/2017, advertisement for appointment of Chairperson and members of Child Welfare Committees (CWCs), under section 30 of the the Act, were circulated for general public through newspapers.

Since response of both these advertisements was inadequate in terms of prescribed qualifications for the Chairperson and members of the committee as laid down in Rule 25.

Consequent upon inadequate number of applicants received for said appointment, the recruitment was thrown open via 'walk-in' interview to all interested and eligible candidates via DIPK-12174/17 and Notification No. MD/ICPS/2018/6318. This was primarily done to increase the pool of candidates and was widely circulated through Social media including FM Radio, AIR Srinagar, Jammu and Ladakh Channels with given date for interview for each district/group of districts.

Under the chairmanship of Hon'ble Justice Hasnain Masoodi, Former Judge J&K High Court, the interviews were conducted by the Selection cum oversight Committee constituted under Rule 89 Vide SRO 75 dated 27/02/2017 in accordance with the prescribed procedures.

A separate panel of candidates for Chairperson and members of CWCs of all 22 districts of Jammu and Kashmir was submitted to Government for notification of the CWCs in exercise of the powers conferred to the undersigned under Rule 90(8) read with Rule 90(9).

**Vide Govt Order No. 52 -SW of 2018 dated 06/02/2018, Govt granted approval to the constitution of committees, and the same are notified hereby in Annexure -A for general public and for the concerned chairperson/members to join as per the terms and conditions given in Annexure-B.**

The vacancies in some the districts where applicants were not found shall be recommended as and when suitable candidates are identified and Selection-cum-oversight Committee takes a decision about filling in such vacancies.

### Annex-B

#### Terms and conditions:

1. The engagement of the candidates shall be subject to outcome of any writ petition (s), if any, in any court of competent jurisdiction.
2. The engagement is purely on contractual basis for a period of three (3) years and extendable upto the age of 65.
3. The candidate shall execute an agreement through medium of a prescribed affidavit duly executed /Sworn before learned Judicial Magistrate to the effect that he/she will have no claim / any right for any permanent absorption/regularization in the State Government at any later stage.
4. This directorate shall get the character antecedents of the candidates engaged verified by the competent authority and the Directorate shall also get the documents/certificates verified from the competent authority to whom a reference shall be made in this behalf and in the event the directorate receives any adverse report with respect to the character antecedents or documents/ certificates furnished/ produced by the candidate, the engagement order shall be treated to have been cancelled ab-initio and appropriate proceedings shall be initiated against such candidate(s).
5. The candidates engaged shall join before the Mission Directorate ICPS J&K Jammu or Camp Office Srinagar within a period of 21 days from the date of issue of this order. In case any candidate (s) fails to join within stipulated period of 21 days, the engagement order shall be treated to have been cancelled ab-initio in respect of such candidate (s) and the member secretary shall operate the waiting list/invite candidates in case eligible candidates are not found in waiting list.
6. The Director ICPS shall allow the candidates to join on production of the following Certificates ( in Original)
  - i. Qualification certificates viz Degree /Marks
  - ii. Permanent Resident Certificate.
  - iii. Age and health Certificates
  - iv. Certificate of experience, if any.
  - v. Certificate from the concerned authority to the effect that no loan under Self employment scheme has been taken by the concerned candidate.



7. The engagement is contractual and can be terminated at any stage in case of poor performance, breach of trust, indiscipline, misbehaviour or any other act which is in contravention to the applicable provisions/ service laws.
