**Subject:- Admission for MD/MS/PG Diploma & MDS 2018 in the State of Jammu and Kashmir – rank of sports category candidates/list of candidates with difficult area marks.**

Whereas, while notifying the list of candidates under sport category quota and those with Difficult Area Marks for consideration of NEET MD/MS/PGD and MDS 2018 vide notification no 015-BOPEE of 2018 dated 13-3-2018, candidates were given an opportunity to make representations up to 15-3-2018 (2 PM) if they so desire and;

Whereas, representations have been received from candidates on the following grounds:-

1. Sports Council has issued certificates to some of the candidates not in accordance with the rules and certificates have been issued after the cutoff date of 27-11-2018.
2. Some candidates have represented that their names have not been included in the sports category list forwarded by the Sports Council and have annexed a copy of the certificate of their Sports event participation to the Board and some have not applied before sports council
3. Representations have also been received that the Difficult Area Marks have to be added for determination of the Merit of the candidates and some certificates have not been considered or were not submitted online.

Whereas, representations have been, examined and considered by the Board and it has been observed as under:-

1. JKBOPEE does not determine the rank of the sports category candidates which is only the mandate of State Sports Council in terms of standing orders. Therefore, the list provided by the sports council has only been considered by the Board. Further the cutoff date of eligibility has been clearly prescribed in page 15 para g(3) of Information Brochure which states that cut off date of eligibility of validity of category certificates for all purposes shall be the last date for registration of candidates and submission of documents as may be fixed by the Board after declaration of the NEET PG Result. Further in terms of Public Notice No. 13 - BOPEE of 2018 dated 28-2-2018 in sub para (V) same position has been stated. The Board had earlier also issued a corrigendum to Public Notice No 76 BOPEE of 2017 dated 2-11-2017 and Public Notice No. 6-BOPEE of 2018 dated 3-2-2018 vide corrigendum dated 4-2-2018. Also, Board has considered all the candidates whose cases have been forwarded by Sports Council. In case of Miss Inakshi Charungoo, Sports Council has not awarded any Marks to her and has as such no claim whatsoever.



2. The Board has now received clearance from Sports Council in respect of one candidate namely Shahid Amin Malla, ID No 1805115687 whose candidature was earlier with drawn and cancelled but has now been restored within the prescribed time by the concerned and the same has accordingly to be considered.
3. In terms of MCI regulations, the Difficult Area Marks are to be considered for determining the merit of the candidates. One candidate who has represented that he could not participate in the Online registration due to an ambiguity in the Information Brochure in para 19 could not apply online and represented accordingly. The same has been examined and candidate found eligible for consideration in view of position explained above . Further, the certificates of the candidates which were not considered earlier or partly be considered and accepted.

Whereas, after having examined and considered the representations, Board has accordingly decided to update the lists of candidates under Sports Category and Difficult Area Marks candidates respectively by inclusion of candidates and updation of the records/ marks as per rules, where ever applicable.

Now therefore:-

Updated lists of sports category candidates with their rank etc and those having with Difficult Area Marks are Annexed herewith as **Annexure "A"** and **"B"** respectively to this notification for general information.


