Subject: Declaration of the Result of Range Officer (Soil Conservation) Mains Examination.

Whereas, vide Notification no. PSC/Exam/2013/102 dated: 12.12.2013 the applications were invited from the permanent residents of the J&K State for direct recruitment to the post of Range Officers in Soil Conservation Department in accordance with the SRO-287 dated: 28.06.1984 read with J&K Public Service Commission (conduct of examination) Rules, 2005; and

Whereas, in pursuance of the Notification, a total number of 107 applications were received by the Commission;and

Whereas, result of the Screening test held on 29.11.2015 for the said post was declared vide Notification no PSC/Exam/2017/03 dated: 31.01.2017, where under 28 candidates were declared to have qualified for the written examination; and

Whereas, the written examination was conducted w.e.f 01.03.2017 to 02.03.2017 wherein 21 candidates appeared in all the subjects/papers; and

Whereas, as per Rule 40 of the J&K Public Service Commission (Business and Procedure) Rules,1980 as amended from time to time the candidates in the ratio of 1:5 had to be called for the interview; and

Whereas, in accordance with J&K Soil Conservation (Gazetted Service) Recruitment Rules, 1984, notified vide SRO-287 of 1984 Dated: 28.06.1984, governs the scheme of examination of Range Officers which prescribes the criteria for qualifying for the viva-voce as reproduced hereunder:-

" Candidate must obtain at least 40% marks in each subject for qualifying the test"; and

Whereas, taking the recourse to the rules governing the scheme of examination, only three candidates out of 21 have qualified the bench mark of 40% marks in all the subjects/ papers.

Now, therefore the candidates bearing the following Roll Nos who appeared in the Range Officer (Soil Conservation) Examination,2015 held by the Commission in the month of March -2017, are hereby declared to have been qualified for interview/Viva-Voce.
