### CABINET DECISION NO. 74/5/2018, DATED: - 24-04-2018.


In pursuance of Govt. Order No:- 639 -EDU. of 2018 Dated :- 26-04-2018 applications are invited from the eligible candidates from the concerned Revenue Village(Rural)/Ward Wise (Municipal Limits) where the post of teacher is available in District REASI for temporarily engagement of teachers purely on academic arrangement for the session 2018-19, till the posts are filled by the Department./ Service Selection Board. **The applications in this regard be deposited in the office of the Zonal Education Officer concerned subject to the following terms & conditions:-**

1. The candidate should be permanent resident of District Reasi.
2. The qualification for the post of teachers as per prescribed rule i.e **Graduation** from the recognized board/ University and **preference will be given to the candidates having higher qualification and those having passed B.Ed /M.Ed.**
3. The monthly remuneration of teachers appointed on temporary (academic arrangement basis) on enhanced rates i.e. @ Rs. 7500/- per month 3<sup>rd</sup> / Hard Zone and @ Rs. 4500/- per month for plain areas.
4. The candidate should be within age limit required under rules as on 01.01.2018.
5. The candidate will be allowed to join provided the post of teacher is vacant.
6. The candidate shall execute an agreement with the concerned DDO that he/she have no claim or right for appointment on permanent basis and there will be no commitment of the state Govt. in this behalf. The Academic Arrangement of the candidate shall automatically ceases or stand cancelled on completion of the academic session or as and when the post is filled on regular basis by Service Selection Board whichever is earlier
7. The candidate will give an undertaking to fact that he/she will not insist for regularization extension /continuation of his/her services on any ground what so ever and will ensure that during engagement the candidate have to abide by Govt. Service conduct rules and as per terms and conditions of engagement provision laid down by the department from time to time.
8. The Merit panel will be prepared at District level and preference will be given to the candidates having higher qualification and those having passed B.Ed/M.Ed.
9. The academic arrangement will be made on the post against the direct recruitment quota vacancies in the department and on the selection of the candidate by the Service Selection Board, the academic arrangement will cease.
10. After receipt of application forms from the eligible candidates, the Merit List will be prepared by ZEO Office Concerned on the basis of marks obtained by the candidate in the academic qualification. However, weightage will also be given to higher qualification acquired by the candidate (as mentioned at para 8 above).
11. There after a final selection list of the candidates will be prepared equal to the no. of direct recruitment vacancies as mentioned in the Govt. Order No. **639 -EDU. of 2018 Dated :- 26-04-2018**

12. The Merit List prepared so far shall be valid for one academic session only.
13. A waiting list of candidates will be maintained and in case an engaged candidate (Teacher) leave the department during the academic session then the next candidate in the merit list will be considered for academic arrangement against the vacancy occurred. The waiting list shall be valid for one academic session only.
14. The candidate will submit their applications on the prescribed format along with following self attested certificates in the office of the ZEO concerned within 10 days (Ten days) from the date of publication of this notification.

- iv) Character Certificate (Any Gazetted Officer)
