Consequent upon the first round of **online counselling held from 5th to 22nd May, 2018** in pursuance of this office Notification No. 027-BOPEE of 2018 Dated 25-04-2018, read with Notice No. 044-BOPEE of 2018 Dated 16-05-2018 for admission to Three Year Diploma Polytechnic Engineering courses - 2018 in Polytechnic Colleges of Jammu and Kashmir State, the candidates provisionally recommended for allotment of Stream/Institution as per their merit and preference indicated by them during online counselling coupled with application of Reservation Rules, are given (Rank wise) at **Annexure-"A"** which shall be available on BOPEE official website www.jkbopee.gov.in only.

The candidates recommended shall report for admission to the allotted Colleges/Institutions on or before **14th of June, 2018** along with their relevant certificates in original and electronic Admit Card of J&K BOPEE. The concerned Heads of the Institutions shall check the eligibility of the candidate and verify inter alia the following documents:

1. Permanent Resident certificate;
2. Marks Certificate (eligibility for open merit 40% and for reserved categories 37% in 10th / Matric Examination);
3. Date of Birth certificate;
4. Category Certificate, if applicable, in original and
5. Proper ID Card to verify the identity of the candidates.



Note:

1. The candidates recommended for allotment shall necessarily have to join the college to be eligible to participate in the upgradation round of counselling if they choose to do so;
2. Admission of any candidate, found to have secured the seat due to concealment of facts or false information, shall be cancelled abinitio besides imposing upon him/her such penalty as may be deemed proper by the Board in accordance with the laid down rules;
3. At the conclusion of first round of online counselling the seats which have remained vacant shall be filled up during the 2nd round of Physical counselling;
4. Board shall notify the schedule for physical upgradation 2nd round of counselling / allotment of seats which shall include seats which have remained vacant during 1st round and those which may remain unfilled due to non joining during first round of counselling;
5. The seat matrix for the 2nd round along with the schedule of counselling shall be notified separately;
6. The Board reserves the right to relax any condition in the interest of the candidates;

The Heads of the Institutions shall keep record of admissions and send the complete list of candidates admitted in different disciplines and shortfall, if any, along with roll no, rank, name and category of candidates who have not completed their admission to BOPEE office Srinagar/Jammu on **18th of June, 2018 upto 02:00 P.M.** positively by fax, email and by hand also. Besides, they shall have to provide the information on the excel sheet as may be forwarded to them by the Board.
