Subject:-Provisional admission to PG Diploma & Rehabilitation Psychology in CRC, 2018. Reference:-(i) Notification No. 106-BOPEE of 2018 dated 18-09-2018; (ii)Notification No. 108-BOPEE of 2018 dated 26-09-2018; (iii)Notification No. 109-BOPEE of 2018 dated 29-09-2018; (iv)Notification No. 114-BOPEE of 2018 dated 11-10-2018.

#### NOTIFICATION NO. 116-BOPEE OF 2018 DATED 24-10-2018

Whereas, vide Notification No. 106-BOPEE of 2018 dated 18-09-2018, read with Notification No. 108-BOPEE of 2018 dated 26-09-2018 applications were invited for admission to PG Diploma & Rehabilitation Psychology, 2018 in Composite Regional Centre, Bemina, Srinagar with the qualification as under:-

- 1. Bachelor's Degree (Regular Mode) with General Psychology Courses in all the three years; or
- 2. Master's Degree in any Branch of Psychology either in Regular Mode or Distance Mode; or
- 3. Master's Degree in Counselling Psychology either in Regular or Distance Mode;
- 4. Have obtained a minimum of 55% marks in aggregate. For SC/ST/OBC, minimum of 50% Marks in aggregate is essential. Entry qualification shall be from a UGC recognized university.

Whereas, the above qualification was notified in pursuance of a communication from Composite Regional Centre, on the subject; and

Whereas, upto the last date of receipt of application forms viz 15-10-2018, 37 applications were received, which have been scrutinized and following has been observed:-

i) Five candidates as under have been found ineligible not possessing the requisite percentage of marks as above and, therefore, their candidature is rejected:-

32 candidates belong to three categories viz those possessing Bachelor's degree with general Psychology Courses in all the three years, those possessing Bachelor's degree with general Psychology Courses in all the three years with Master's degree in any branch of Psychology and those possessing only Master's degree in Psychology in accordance with the above qualification have been found eligible;

Whereas, the Board having considered the matter in totality accordingly devised the following criteria for making selections:-

- i) 90% weightage on pro-rata basis to the marks obtained in qualifying examination viz Bachelor's degree/ Master's degree in Psychology as the case may be;
- ii) 10 additional points to the candidates possessing Master's degree in any branch of Psychology in addition to Bachelor's degree with general Psychology and;

Whereas, on the basis of above, the merit list of 32 eligible candidates has been prepared and forms **Annexure-A** to this Notification;

Whereas, on the basis of inter se merit of the eligible candidates with due regard to reservation rules, the candidates as per Annexure-B have been shortlisted for admission to PG Diploma & Rehabilitation Psychology, 2018 in Composite Regional Centre, Bemina, Srinagar and is notified accordingly and also waiting list is also notified as Annexure-C to this Notification.

Now, therefore:-

- the candidates as per Annexure-B to this Notification are hereby provisionally selected for admission to PG Diploma & Rehabilitation Psychology, 2018, who shall report to the Composite Regional Centre, Bemina Srinagar, Kashmir upto 1<sup>st</sup> November, 2018 along with all necessary documents for verification and further scrutiny and the said college shall allow them to join only on production and verification of original requisite certificates;
- ii) The candidates as per Annexure-C to this Notification have been placed in the waiting list, which shall be operated upon by the Composite Regional Centre, Bemina, Srinagar only w.e.f. 2<sup>nd</sup> November, 2018 against the seats which would remain vacant due to the non joining of the candidates figuring in Annexure-B. The joining time in such cases shall be upto 10<sup>th</sup> of November, 2018;
- iii) Any candidate aggrieved of the above selection can represent to the Board upto 27<sup>th</sup> November, 2018 with all documentary evidence, which shall be considered by the Board on the basis of the merit. After the said date no representation shall be entertained and the merit list shall be deemed to be final.
