AND WHEREAS, the J&K Public Service Commission, Jammu forwarded the selection list of the suitable candidates vide following communications with selections indicated against each:-

AND WHEREAS, out of 113 posts of Medical Officers advertised vide above referred to communications by the J&K Public Service Commission, selection list in respect of only 88 candidates have been communicated by the Commission. The remaining 24 posts of Medical Officers falling under various categories have remained unfilled due to the reason that either the candidates did not achieve the bench mark of the percentage for that selection or candidates were not available in the relevant category as communicated by the J&K Public Services Commission and the result of one candidate has been kept withheld.

Now, therefore, as recommended by the J&K Public Service Commission, Sanction is hereby accorded to the temporary appointment of 88 Medical Officers (05 of Homeopathy, 53 of Ayurvedic & 30 of Unani discipline) in the Department of Indian Systems Of Medicine in the pay band of Rs. 9300-34800 + GP 5400 (pre-revised);- now revised to Level-9 (52700-166700) along with their postings as indicated in **Annexure A,, B, C & D** to this order with immediate effect, subject to the following conditions:-

- 1 The appointee(s) shall submit their joining reports to their concerned Drawing and Disbursing Officers (DDOs) within a period of 21 days from the date of issuance of this order and in case of failure of any appointee to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice;

- 2 The appointee(s) shall be allowed to join by the concerned Drawing and Disbursing Officers (DDOs) only on production of the following certificates in original:-
- (i) Qualification Certificates (Academic and professional).
 - (ii) Matriculation/Date of Birth Certificate
 - (iii) Health Certificate issued by the Standing Medical Board.
 - (iv) Permanent Residence Certificate issued by the Competent Authority.
 - (v) Certificates from the District Industries Centre (DIC) and District Employment and Counselling Centre to the effect that no loan under the self employment scheme has been taken by the appointee
 - (vi) Relevant category certificate(s) (in case of candidates belonging to reserved categories)
 - (vii) Any other certificates/documents as required under rules/norms.
- 3 The appointee(s) shall not be allowed to continue with PG/Tenures of Senior Residency/Registrarship/Demonstrator ship and they will have only one choice either to opt for appointment or opt out of it and continue with their PG/Tenures of Senior Residency/Registrarship/Demonstrator ship in which case candidates from the waiting list will be considered for appointment.
- 4 Each appointee shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police (CID), J&K to whom a reference shall be made by the Directorate of Indian System of Medicines, J&K, Jammu after the cases for such verifications are received from the concerned Drawing and Disbursing Officers (DDOs), he/she shall have no right to claim his/her appointment as Medical Officer and his/her appointment as such shall be deemed to have been cancelled ab-initio without any further notice
- 5 If on verification, the certificate(s) produced by the appointee(s) are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio without any further notice;
- 6 The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (4) & (5) above are received in their favour
- 7 The appointee shall be on probation for a period of (02) years and their confirmation shall be made under provisions of

Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules 1956.

- 8 The appointment of these candidates shall be governed by the new pension scheme as per SRO-400 of 2009 dated.24.12.2009.
- 9 The appointees shall give an undertaking duly attested by the First Class Judicial Magistrate in shape of an affidavit to the effect that;
- (i) He/she shall abide by all the terms & conditions as laid down in this appointment order.
 - (ii) He/she shall not be eligible for transfer for whatsoever reasons during the temporary service of (02) years and in case of candidates who are residents of backward areas or an area adjoining Line of Actual Control, for a period of not less than 07 years.
 - (iii) He/she shall be liable for action as warranted under rules for violating any of the laid down conditions in this appointment order.
- 10 The interim arrangement, if any, made on contract/deputation or an academic arrangement basis against the aforesaid posts of Medical Officers shall be deemed to have been terminated forthwith.
- 11 The inter-se-seniority of the appointees shall be drawn in accordance with the merit secured by these appointees in the selection list prepared by the J&K Public Service Commission and shall be notified separately.
- 12 The appointment shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.
