5. Certificate from District Industries Centre (DIC) and District Employment Counseling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
6. Total marks obtained and percentage of selectees be also got verified/authenticated from original certificate.
7. Permanent Resident Certificate issued by Competent Authority.
8. Character antecedent Certificate issued by the Police Department.
