In pursuance to advertisement notification No. SHS/NHM/J&K/HWC/4837-4843 and SHS/NHM/J&K/HWC/4844-4853 dated 19-06-2019, it is hereby notified that the list of provisionally selected BAMS/ BSc Nursing/ GNM candidates along with district wise waiting list for undergoing Bridge Programme Six (06) Months Certificate Course in Community Health (BPCCHN) through IGNOU for session July 2019, for Jammu Division is placed *as Annexure "A"* and for Kashmir Division is placed *as Annexure "B"*. The 1st waiting list of provisionally selected BAMS/ BSc Nursing/ GNM candidates for counseling and placement in districts other than their domicile district is placed *as Annexure "C"* for Jammu Division Candidates.

documents.

5. The provisionally selected candidates of Jammu Division are directed to bring Fixed

Kashmir Division shall be uploaded separately.

Any candidate who is already working as Regular/ NHM Contractual is not allowed

to undergo the said course. Further if it is found that any of the candidate has

concealed any material fact or has been selected on the basis of any

misrepresentation during the process of selection, he / she shall be debarred from

undergoing the Bridge Programme six (6) months Certificate Course in Community

Health, besides he/ she shall be liable for legal action.
