Subject: Result of Jammu & Kashmir Civil Services (Judicial) Competitive Examination, 2018 - Deployment of Candidates for Medical Examination.

Notification No.: PSC/Exam/64/2019

Dated: 22.08.2019

Whereas, the Department of Law, Justice & Parliamentary Affairs vide letter No. LD(A)2010/70 dated: 21.05.2018 referred Forty Two (42) vacancies of Civil Judge (Junior Division)/Munsiffs in the Subordinate Judiciary to the J&K Public Service Commission for being filled up in accordance with Jammu and Kashmir Civil Service (Judicial) Recruitment Rules, 1967 read with SRO No.5 dated 04.01.1968 and SRO 254 of 2017 dated:20.06.2017; and

Whereas, these posts were advertised by the Commission vide Notification No. PSC/Exam/2018/39 dated: 30.05.2018; and

Whereas, in response to the above advertisement 2984 Application Forms were received; and

Whereas, Preliminary Examination was conducted on 28.10.2018 in which 2305 candidates appeared in full in the Examination; and

Whereas, the result of the Preliminary Examination was declared on 17.11.2018 in which 793 candidates including three Physically Challenged candidates qualified for Jammu & Kashmir Civil Services (Judicial) [Mains] Examination-2018 vide Notification No. PSC/Exam/19/2018 dated:17.11.2018; and

Whereas, KCS(Judicial) Main Examination was conducted from 23.03.2019 to 04.04.2019 both at Jammu and Srinagar centres in which 690 candidates appeared in all papers; and

Whereas, as per the criteria fixed by the Commission, in its 20th Extra Ordinary meeting held on 20.06.2019, in accordance with the aforesaid rules, 162 candidates were declared to have qualified for interview vide Notification No. PSC/Exam/44/2019 dated: 20.06.2019; and

Whereas, the interview of the said candidates was conducted w.e.f 08.07.2019 to 24.07.2019 & 27.07.2019; and

Whereas, the Department of Law Justice & Parliamentary Affairs vide communication dated:05.03.2019 intimated that the Hon`ble Full Court has recommended the provisions of J&K Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 and the rules framed thereunder as also the Government Order issued by the Social Welfare Department under section 21 of the said act with necessary modifications from time to time be extended to the post of Munsiff after prior consultation with the J&K Public Service Commission. The Commission from time to time and latest vide letter dated:30.07.2019, sought the clarification, regarding the number of posts to be earmarked for physically challenged candidates from the Department of Law Justice & Parliamentary Affairs in view of the communication dated:05.03.2019 of Department of Law Justice & Parliamentary Affairs, the response from the said Department is still awaited; and

Whereas, in the meanwhile, the Commission on 30.07.2019 received the directions of Hon`ble High Court dated:03.07.2019 passed in the WP(C) No.2451/2019 CM No.4910/2019, wherein the Public Service Commission has been directed to allow the petitioner of PHC category candidate to participate in

the process of viva-voce. This order was however at the risk and responsibility of the petitioner. Besides, the result of the petitioner is not to be declared until further orders from the Hon'ble Court; and

Whereas, the matter was placed before the authorities for directions and it has been approved that all the three PHC candidates who have appeared in the Jammu & Kashmir Civil Services (Judicial) [Mains] Examination-2018 be summoned for the viva-voce test pending clarification from the Department of Law Justice & Parliamentary Affairs and on the referred directions of the Hon'ble High Court; and

Whereas, the Commission in its 26th Extra Ordinary Meeting held today on 22.08.2019 decided to declare the result of all the candidates who had appeared in the interview and also to notify their aggregate marks while publishing a list of candidates to be summoned for Medical Examination in accordance with the relevant rules. Besides two posts be kept reserved for PHC candidates, one each from OM & RBA category.

Now, therefore, in pursuance of the provisions contained in the Jammu and Kashmir Civil Service (Judicial) Recruitment Rules, 1967 read with SRO No.5 dated 04.01.1968 and SRO 254 of 2017 dated:20.06.2017, read with J&K Public Service Commission (Conduct of Examinations) Rules 2005 as well as the above decision taken by the Commission;

- i) The result of 161 candidates, who had appeared in the interview of Jammu & Kashmir Civil Services (Judicial) Competitive Examination-2018 at Srinagar w.e.f. 08.07.2019 to 24.07.2019 & 27.07.2019, is hereby notified as per Annexure-I to this notification.
- ii) Consequent upon (i) above 40 candidates as per Annexure-II of this notification and other rules on the subject, by order of their aggregate merit in the written as well as interview have qualified for Medical Examination and are directed to report to the respective Medical Boards constituted/or to be constituted in GMC Jammu & Srinagar for conduct of their Medical Examination, in accordance with rules on the subject.

The candidates recommended for medical examination will have to pay a fee as prescribed before Medical check-up.

Note:

1. Mere calling a candidate(s) for Medical Examination shall not confer any right on him/them to be recommended for selection.
2. Detailed marks cards shall be available on the website of the Commission after completion of the examination process and after forwarding the select list to the government for making appointments.
3. The above lists notified as Annexure-I & II to this notification are provisional and subject to the outcome of the writ petition(s), if any, pending before any Competent Court of jurisdiction.
