ORDER

Sub:- Guidelines/ Instructions on lockdown measures in District Reasi w.e.f. 20-5-2020-COVID-19 regarding.

Ref:- Government order No. 55-JK(DMRRR) of 2020 dated 19-5-2020

Whereas, the Government of Jammu & Kashmir vide its Order No. 54 - JK (DMRRR) of 2020 dated: 19-5-2020, has classified the districts into Red, Orange and Green categories for Jammu and Kashmir where under, beside other districts of Jammu and Kashmir, District Reasi has been classified under Orange category;

Whereas, the Government of Jammu & Kashmir vide its Order No. 55-JK (DMRRR) of 2020 dated: 19-5-2020, has issued latest guidelines on lockdown measures for different zones viz Red, Orange and Green zones which will come into effect from 20th May 2020.

Now therefore, in view of the above quoted orders, I, Indu Kanwal Chib, KAS, Chairperson, District Disaster Management Authority, Reasi in exercise of powers vested under Section 34 of the Disaster Management Act, 2005, do hereby issue the following guidelines/instructions with effect from 20th of May 2020 till further orders:-

A. Non-permissible activities in District Reasi: -

- All schools, colleges, universities educational training coaching institutions (including Aanganwadi Centres) etc. shall remain closed. However, their offices are allowed to function for administrative purposes with minimum strength.
- All Cinema Halls/Shopping Malls/ Gymnasiums/Swimming Pools/ entertainment parks/Theatres/ Bars/ Assembly Hall etc. shall remain non-permitted.
- All Social/Political/Sports/Accademic/Cultural/Religious functions/other gatherings and congregations shall remain non-permitted.
- All religious places/place of worship shall be closed for public. Religious congregations are strictly prohibited.
- The movement of individual for all non-essential activities between 7:00PM to 7:00AM shall remain prohibited.

- Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years shall stay at home, except for meeting essential requirements or for health purposes.
- No inter-state, inter-district and intra-district movement of public transport is permitted.

B. Activities permitted in District Reasi: -

- Normal functioning of Private Hospitals, Clinics and Nursing Homes (including OPD services).
- 2. All E-commerce and Courier services.
- All Agriculture, Horticulture, Animal Husbandry and related activities.
- Banks and financial services.
- 5. All restaurants, including in hotels, can operate kitchens for home delivery only.
- Canteens/Eateries at Bus Stands.

For point No. 5 and 6, all eatery owners are required to replenish old stock and ensure proper hygiene maintenance. They may resume their units only after the working staff gets themselves screened for COVID-19 and certified to be fit for work by District Hospital Reasi. Chief Executive Officer Municipal Committee Katra & Executive Officer Municipal Committee Reasi along with Food Safety Officer Reasi shall ensure that the eatery owners have obtained certificate to be fit (MANDATORY) and adequate safety measures are taken;

- 7. Liquor Shops with condition that social distancing is maintained.
- 8. Barber shops, saloons and parlours in all areas except within the Municipal Limits.
- 9. Self-employed service providers such as Plumbers, technicians, electricians etc.
- 10. Marriage related functions with not more than 50 persons maintaining social distancing.
- 11.Funeral/last rites related rituals with not more than 20 persons maintaining social distancing;
- 12.All shops including those in market areas/bazaars/market complexes, except

 Single branded/Multi branded malls which shall continue to be prohibited,
 shall be allowed to operate. Following shall be noted:
 - i. The shops shall remain open from 9 AM to 5 PM.

- ii. There shall be no parking on roads of bazaars/market complexes market areas.
- iii. Shop Owners should not keep articles of sale on the pavements and shall not encroach upon the road by extending their counters thereby causing congestion in the markets.
- iv. Any establishment/shop/unit, if found not following the social distancing, masks or adequate sanitizing norms, may be sealed immediately by the concerned Executive Magistrate.
- v. Any four wheeler vehicle, if found, wrongly parked in market area in front of shop shall be seized.
- Sports activities in stadia and sport complexes (without the presence of the spectators).
- 14. Intra-district movement of individuals in vehicles is allowed with a maximum of two (02) persons besides the driver in four wheeler vehicles and with no pillion rider in case of two wheelers.
- 15. The inter-district movement of persons in private vehicles between a pair of green/ orange districts without crossing a red district with a maximum of two passengers, besides the driver, in four wheeler and with no pillion rider in case of two wheeler. It is important to note that Ramban District is in Red Category and Jammu, Udhampur and Rajouri have been categorized as Orange districts, so, any inter-district movement from Udhampur, Jammu & Rajouri and vice versa shall be permitted but such movement shall not be allowed from/to District Ramban.
- 16. Auto-rickshaws with a maximum of two passengers, only intra district.
- 17. Cab aggregators are permitted to ply with one driver and two passengers only, only for intra district movement.

C. Industrial & Services activities

- 18. Industrial activities can resume at all Industrial Estates with only 50% workforce.
- 19. Industrial activities can resume in all rural areas with 100% workforce.
- 20.All workshops, service centers and home work shops can operate with not more than 5 persons working on site/ inside premises.
- 21.All industries will have to comply with the health, safety and other instructions as per

SOP for Industrial activities issued by the Government vide order No. 55-JK(DMRRR) of 2020 dated 19-5-2020.

D. Rural Construction activities

- 22. There shall be no restriction on construction activities in rural areas including UT/Central Government projects/works. All field level authorities would ensure:
 - a. Maintenance of social distancing.
 - Use of protective face covers/masks.
 - c. Frequent washing of hands with soap and water themselves and by MGNREGA workers.
 - d. Arogya Setu App will be promoted/downloaded among MGNREGA workers to the extent possible.

E. Private Construction activities

- 23. I. Private construction activities shall be allowed without any need for permits/ permissions except within municipal limits. Health precautions and following instructions will be strictly required to be followed
 - a. Efforts will be made at minimizing the commuting.
 - b. Sanitization of high quality of premises shall be ensured.
 - Health & Hygiene of high standard shall be ensured by Unit holders/Management.
 - d. Social distancing shall be ensured.
- II. For municipal limits, construction activities passes shall be required from Assistant Commissioner Revenue/SDM Concerned on case to case basis. The labour in all projects in Municipal limits have to **be kept in situ.**

F. Inter-Province and Inter State movement

- There shall be no inter-province and inter-state movement of individuals except after obtaining passes from Divisional Commissioner concerned.
- ii. Passes are not required for movement of Goods carrier, within the Union Territory of Jammu and Kashmir, with one driver and one cleaner and who is in possession of valid driving license and valid bills or challan or certificate of the dispatch from the supplier with his phone number.

iii. It is advised that Aarogya Setu App to be downloaded by all for

employees/shopkeepers/ Members of PRIs etc.

Further, it is reiterated that all the establishments working in the territorial jurisdiction of District Reasi shall take preventive steps to follow social distancing and ensure adequate sanitizing norms in the area. Any establishment/unit/shop found not following the said norms shall be booked under law. Moreover, it shall be mandatory for the general public of the district to wear face masks while coming out of their houses.

Senior Superintendent of Police Reasi is requested to ensure the adequate police deployment so that the above directions are implemented in true letter and spirit.

Since it is not possible to serve this order individually, it shall be circulated in print, electronic and social media for the information of all concerned. Any violation of this order shall lead to prosecution under section 51 of the Disaster Management Act 2005.

All passes already issued by this office for daily movement shall remain valid till the extended lockdown period as well.

The order shall come into force with immediate effect.
