Subject: Restrictions in District Samba under Section 144 of Cr.P.C.

**ORDER**

In partial modification to this office order No. DMS/Misc/2020/Covid-19/1898-1908, dated: 14-05-2020, the following is ordered;

Whereas, vide order No. DMS/JC/2019-20/1133-44, dated: 25-03-2020, restrictions were imposed under Section 144 of Cr.P.C in the District Samba and through the same order exemptions were also granted.

Whereas, in the last few days MHA and Union Territory Government has extended few more exemptions in order to facilitate the people for different services. In view of that all the exemptions are rescheduled along-with the new ones;




4	Barbar shops in Non-Municipal (Rural Areas) only. <b>Two customers at a time inside the shop.</b>	Wednesday & Sunday (2 days per week)	7 AM to 11 AM
5	Movement of Plumbers, Technicians & Electricians	Daily	10 AM to 4 PM

All these shops will follow the following conditions strictly;

- i. The owners will strictly follow the above given schedule and timings.
- ii. Only 50 % of the staff of the shop will remain present in the shop at any given time.
- iii. The shopkeepers and helpers will wear masks and maintain social distancing.
- iv. The shopkeepers will have to provide sanitizers / soap to staff as well as customers.
- v. This has been ordered on **trial basis**, if any, violation is found it will be withdrawn forthwith.

It is mandatory for all the shopkeepers to **download Aarogya Setu Mobile App** in their mobiles. Anybody found violating these norms will be dealt firmly.
