

Subject: Relaxations amid COVID-19 lockdown-regarding.

ORDER

In supersession of all previous orders and in view of the prevailing situation of COVID-19 and in exercise of power conferred upon me in my capacity as Chairman, District Disaster Management Authority under section-34 of Disaster Management Act, 2005 as well as under Section -144 of CrPC, 1973; it is hereby ordered that:

1. All Industrial/Construction activities within rural and urban activities shall be permitted.
2. Usage of Mask, Downloading of **Aarogya Setu App**, and practice of Social Distancing shall be mandatory.
3. Complete ban on plying of private vehicles. However, in case of emergency private vehicles are allowed with prior permission from the office of the undersigned.
4. Complete ban on plying of commercial taxis. However, in case of emergency commercial taxis are allowed (Medical emergencies or any other type of emergencies) with prior permission from the office of the undersigned.
5. Inter-District movement of vehicles shall not be allowed (i.e. from Kargil to Leh & Vice versa) without permission.
6. Only essential service shops are permitted to open. However, these shops shall follow the roster as approved by the office of the undersigned. Further, the shops shall ensure minimum six feet distance among customers and shall not allow more than 2 persons at the shop at one time. Making of circles shall also be mandatory for ensuring social distancing and maximum of two staff shall work. (**Roster attached**)
7. Public Transport shall continue to be banned.
8. Restaurants shall not be permitted to operate kitchen for Home delivery of food items.
9. The above arrangements shall be in place between 07:00AM to 07:00PM.
10. Persons above 65 years of age, person with co-morbidities, pregnant women, and children below the age of 10 years, shall stay at home , except for essential and health purposes.
11. Gathering of more than 4 people shall continue to be banned.
12. People who are under the home quarantine shall follow the rules strictly as per the guidelines.
13. Spitting in public places shall be prohibited.

14. The following activates shall continue to remain prohibited:-

- I. Schools, Colleges, Educational/Training/Coaching Institutions etc. will remain closed. (Online /distance learning shall continue to be permitted and shall be encouraged).
- II. Hotels, restaurants and other hospitality services, except those meant for housing health/ police/ government officials/ healthcare workers/ stranded persons including tourists and for quarantine facilities.
- III. All gymnasiums, entertainment parks, bars, assembly halls and similar places. Sports complexes and stadia will be permitted to open; however, spectators will not be allowed.
- IV. All social/ Political/ Sports/ entertainment/ academic/ cultural/ religious functions/ other gatherings and large congregations.
- V. All religious places/places of worship shall be closed for public. Religious congregations are strictly prohibited.


"All the above relaxations shall not be applicable to the containment Zones"

However, all SOPs and directives as laid down by **MHA vide order No. 40-3/2020 -DM-I (A) dated 17th May, 2020** and order issued by the **Chairman, State Executive Committee, Ladakh Disaster Management Authority UT Ladakh vide No. DMRRR/UTL/SOP/COVID-19/2020/7802-7819 dated 08.06.2020** shall be followed in letter and spirit. Addl. District Magistrates, Kargil shall constitute committees to ascertain the implementation of above directives in letter and spirit.

This order shall come into force with immediate effect and will remain enforce till 30.06.2020.
