Subject: COVID-19 lockdown - Imposition of restrictions thereof.

ORDER

In continuation to this office order No. DCL/PS/COVID-19/OO/2020/657 Dated: 08-06-2020, and due to categorization of Leh District as "Red", following arrangements in addition to the previous restrictions are hereby ordered w.e.f. june 14, 2020 till further orders:

- Shops except Barber Shops shall be allowed to open as per the days and timings mentioned in the roster annexed as appendix "A".
- 2. Public transport (Buses/Mazda) shall not be allowed to ply.
- Private & Commercials vehicles (meant for non-essential services) shall be allowed to ply on ODD/EVEN basis as mentioned below:
 - Monday/Wednesday/Friday/Sunday: (Vehicle Registration number ending with numbers 1,3,5,7,9)
 - Tuesday/Thursday/Saturday:

(Vehicle Registration number ending with

numbers 0,2,4,6,8)

- 4. The essential services which are exempted from ODD/EVEN system are :
 - i) All the Govt. Vehicles.
 - ii) Vehicles for Medical Emergencies.
 - iii) Vehicles entrusted with Power supply/ Water supply/ Municipal Committee/ any emergency restoration etc.
 - iv) Vehicles with Telecom Service Providers (TSPs).
 - v) Vehicles of Bank Staffs
 - vi) Vehicles entrusted with distribution/transportation of Fuels/Oils/LPG.
 - vii) Vehicles entrusted with transportation/distribution of constructions materials etc meant for public works. However, such vehicles shall continue to take prior permission from entering Municipal limits in between 07:00 AM to 07:00 PM.
 - viii) Vehicles meant for passengers/officials going to/from airport upon the production of tickets/boarding pass/ ID cards issued by the Airport Authority of India.
 - ix) Vehicles of Govt. employees.
 - x) The above exemptions shall be applicable upon the production of valid ID-card.
 - xi) For exceptional cases, individuals can apply for e-passes on https://leh.nic.in/epass/.

- Restaurants shall be allowed to open for home delivery only as per roster attached.
- Restrictions on plying of private vehicles meant for non-essential services shall continue in between 09:00 PM to 05:00 AM without prior permission.
- All SOPs and instructions regarding social distancing, precautionary measures etc.
 issued in previous orders shall continue to be valid.
- 8. All instructions related to home quarantine shall be followed in letter and spirit.

In case of any violation, penal action under Section-51 of Disaster Management Act, 2005 and Section 188 of IPC and other relevant laws shall be initiated.

Addl. District Magistrate, Leh and Sr. Superintendent of Police, Leh along with SDMs/ Executive Magistrates shall ensure the implementation of above order in its letter and spirit. Random/Surprise checking shall be ensured in their respective jurisdictions.
