Subject: - Conduct of second round of Physical Counselling for

upgradation/allotment seats in B.E./B.Tech. Engineering Courses, 2020 in

Government/Private Engineering Colleges of UT of J&K /Ladakh

Reference: (i) Notification No. 039-BOPEE of 2020 dated -21-10-2020.

Notification No: 043-BOPEE of 2020 Dated: 02-11-2020.

After the receipt of shortfall from Engineering Colleges and unfilled Seats available in various Disciplines of B.E/ B.Tech. (Engg.) courses in Government/Private Colleges of UT of J&K, the Board shall fill up the same and conduct second round of Physical Counselling for allotment /upgradation of seats tentatively w.e.f 05-11-2020 as per the schedule given below:-

After conclusion of the counselling for reserved categories on 06-11-2020, the unfilled reserved category seats shall be converted to OM as per the provisions under Section-9 of J&K Reservation Act, 2004 and filled up accordingly from amongst the OM candidates.

PROCEDURE FOR SECOND PHYSICAL UPGRADATION/ALLOTMENT ROUND OF COUNSELLING:

The following procedure shall be followed:

- Subject to the limits fixed by the Board due to COVID-19, the candidates as notified by 039-BOPEE of 2020 dated 21-10-2020 and qualifying for the upgradation/ allotment of seats in the Second round as per laid down norms shall attend the counselling on the day /date and time mentioned hereinabove;
- The eligible and willing candidates have to report at the BOPEE offices Jammu / Srinagar for registration/attendance & fulfillment of all formalities, from 08:00 AM upto 10:00 AM on their day/date of counselling.
- 3. The candidate(s) participating in the physical round of counselling and getting allotted a seat, should in their own interest not to leave the Board office as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling may become available during the process. He/ She can stake a

claim on such a seat immediately once the seat is displayed in the seat matrix on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis. The seat allotted to him/her earlier shall become vacant and be added to the seat matrix. The Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as above.

- 4. The candidates who have not joined the college on allotment of seat in the first physical round of counselling shall not be eligible to participate in the upgradation/second physical round of counselling.
- 5. Candidate who has opted for C.N.A/S.N.A or who could not attend counselling due to unavoidable circumstances and the candidates who belong to TFW category with valid certificate issued by the Competent Authority but had not filled online TFW category are eligible to attend the second round of Physical Counselling for up-gradation / allotment of seats in B.E/B. Tech. (Engineering) courses.
- 6. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.

Note:

- i) All the candidates reporting at BOPEE offices Jammu/ Srinagar shall strictly adhere to COVID-19 Advisories issued by the UT Government of J&K from time to time.
- ii) Seat matrix shall be uploaded separately within due course of time before counselling.

The other terms and conditions shall remain the same as notified in the Information Brochure and Notifications/Notices issued in this regard from time to time.
