

Admission / upgradation round of physical counselling of MBBS/BDS

Consequent upon the conduct of second round of counselling (physical) from 19.12.2020 to 23.12.2020 in pursuance of Notification No. 59-BOPEE of 2020 dated 07.12.2020 and on the basis of merit cum preferences and application of reservation rules, the candidates upgraded/selected for undergoing MBBS/BDS courses (2020) in various colleges of UT of J&K, is hereby notified as per **Annexure "A"** to this notification, available on website of the Board http://www.jakbopee.gov.in only. The candidates shall report to the colleges allotted to them upto **28.12.2020** (3.00PM) alongwith necessary documents including the following for admission:-

- 1. Date of Birth Certificate
- 2. Marks Card of 10+2
- 3. Domicile Certificate
- 4. Category certificate, if any
- 5. Valid Income Certificate of P&B category candidates
- 6. NRI / HM Certificates/ documents
- 7. Any other certificate demanded by the College Authorities

The College Authorities shall keep admission counters open even on holidays/ off days and designate Nodal Officers to facilitate the candidates in the process of admission. They shall also request the concerned Bank Branches falling their areas to keep the Branches open on the holidays also to enable the candidates to make payment of fee etc. on such days. However, the candidates should, in their own interest, avoid waiting for the last day to complete the admission formalities; as such delay has the potential of causing hardships to the candidates only.

The Colleges shall submit the shortfall, if any, by 28th of Dec.2020 upto 4.00 PM positively to enable the Board to take further necessary action in the matter.

Note:-

- 1. The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/ fabricated, and action as warranted under law shall be initiated against such candidates.
- 2. The other terms and conditions shall remain same as notified by the Board in e. Information Brochure/ Notifications/ Notices issued from time to time
- 3. The concerned Colleges/ Institutions shall ensure that, any person with disability, if selected in open merit or some reserved category, fulfills the eligibility bench marks, as provided in MCI Regulations, constitute a special Medical Board to assess such candidates and make recommendations based on which colleges shall take further necessary action. In case any such candidate does not fulfill the bench marks of eligibility, he/ she shall not be admitted to the course/ college and the matter shall be reported to the BOPEE. Such a seat shall be deemed to be vacant and filled-up out of the waiting list to be maintained by the Board in order of merit during the process of counselling to be held later on. The ASCOMS, if any, shall have to get such candidates, examined through the Standing Medical Board at GMC, Jammu.



- 4. The seats, if any, which remain un-filled shall be filled-up along with the seats, if any, received as shortfall on a date as may be notified by the Board in due course of time.
- 5. The Heads of the Institutions/ Colleges are requested to release the documents and fee to the candidates who have been upgraded during this round of counselling without wasting their time to enable them to report to the upgraded college by or before 28.12.2020.

The mop-up round of unfilled and vacant seats reported through shortfall, if any, received by the Board from the Colleges, shall be held on 29.12.2020 at BOPEE office, Srinagar/ Jammu simultaneously and the candidates shall have report at 9.00 A.M to 10.30 AM for Registration/ Attendance. This schedule of mop-up round is subject to the availability of seats. However, seat matrix regarding above shall be uploaded on 28th of Dec. 2020 evening on website of the Board separately (http://www.jakbopee.gov.in)
