Whereas, it appears to the Government of UT of J&K that a total of 02 kanals 14 Marlas land is required in the village Dhakhnaka Tehsil Kathua District Kathua for public purpose, namely for construction of Main Ravi Canal from Basantpur to Shahpur Kandi Dam. Regarding Rehabilitation & Resettlement Policy, and Social Impact Assessment Study, it has been reported by Chief Engineer, Shahpur Kandi Dam Project, vide his No. 8124/SPK-112-RC dated 11-11-2020, through Chief Engineer, RTIC, Department, Jammu vide its No. CE/RTIC/J/1667-73 dated 11-11-2020 that Rehabilitation & Resettlement Plan is already approved and Environmental clearance granted for this Project after conducting Social Impact Study (SIS).

No family is likely to be displaced due to the land acquisition.

The Additional Deputy Commissioner, Kathua has been appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families.

Therefore, it is notified that for the above said project in the village Dhakhnaka Tehsil and District Kathua, a piece of land measuring 02 kanals 14 Marlas, of standard measurement whose detailed description is as following , is under acquisition:-

This notification is made under the provisions of section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, to all whom it may concern.

A plan of the land may be inspected in the office of the undersigned on any working day during the working hours.

The Government is pleased to authorize Chief Engineer Shahpurkandi Dam Project and his staff to enter upon and carry survey, take level of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase etc, or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person interested within 60 (sixty days) from the date of publication of this notification as provided under section 15 of the Act before the undersigned.
