Whereas Drugs Control Officer (Concerned) have reported that above mentioned firms have been found violating the norms and conditions of Licenses as mandated under the relevant provisions of Drugs & Cosmetics Act,1940 & rules there under ;

Whereas the Concerned Drugs Control Officer , have served Notices upon the above firms for breach /violations of the relevant provisions/ conditions of the Licenses;

Whereas the firms were asked to submit reply to the notice within weeks time positively without fail, failing which action under Law shall follow;

Whereas again a Final Show Cause Notice was served upon the above firms through Public Notice published in Leading Daily Newspapers dated 10.10.2020;

Whereas the above firms have again not replied to the above said Notice till date;

Whereas the concerned Drugs Control Officer have now recommended that Drug Sale Licenses in favour of the above firms be cancelled for contravention of the provisions of the Act ;

Now, therefore, I Lotika Khajuria ,Licensing Authority for Wholesale Establishments in Jammu Division appointed vide SRO 389 dated 02.12.2009 hereby Order the Cancellation of the above firms in Form 20B/21 B as provided under Rule 66 of Drugs & Cosmetics Rules, 1945 with immediate effect.
