Subject: Tentative Seniority list of Superintendents in Industrial Training Institutes (ITIs) as on 01.01.2021.

Circular No. 01 -JK(DSD of 2021

Dated : 08 -01-2021

Whereas, vide Government Order No. 30-Edu(Tech) of 2002 dated 05.03.2002, under endorsement No. Edu/Tech/ITI/10/2000 dated 05.03.2002, the final seniority list of Superintendents of Industrial Training Institutes (ITIs) has been issued.

Whereas, from the date of issuance of the above seniority list, various number of appointments under the direct recruitment quota through J&K, Public Service Commission have been made in the Superintendent cadre. Besides, some Superintendents have already retired from Government Service.

Whereas, Vide Government Order No. 222-Edu(Tech) of 2014 dated 11.12.2014, initial constitution and final seniority list of Gazetted Officers in ITIs of Department of Skill Development as it stood on 29.08.2002 was issued which was later withdrawn vide Corrigendum under endorsement No. Edu/Tech/ITI/27/2012 dated 23.03.2015, the initial constitution and final seniority list of Gazetted Officers as it stood on 29.08.2002 was deemed to be treated as eligibility list, to be submitted to DPC/PSC except those officers included in the final seniority list issued vide Government Order No. 30-Edu(Tech) of 2002 dated 05.03.2002 as Superintendents.

Whereas, the validity of Government Order No. 222-Edu(Tech) of 2014 dated 11.12.2014 was challenged in the Hon'ble High Court in writ petition titled Nazar-ul-Islam and others Vs State of J&K & Ors bearing SWP No. 183/2016.

Whereas, the Hon'ble High Court, while disposing of the above mentioned writ petition directed as under:-

"respondents to consider petitioners' claim in light of averments made in petition, annexures appended thereto and rules occupying the field, within a period of six weeks from the date copy of this order is served upon respondents. Till petitioners' case is considered and decision taken, respondents


are expected not to act upon order No. 222-Edu(Tech) of 2014 dated 11.12.2014."

Whereas, 26 more appointments have been made in the Department against the post of Superintendent vide different Government Orders (viz No 51-Edu(Tech) of 2004 dated 20.04.2004, No 92-Edu(Tech) of 2010 dated 14.05.2010, No. 189-Edu(Tech) of 2013 dated 25.10.2013 and No 53-Edu-(Tech) of 2017 dated 30.05.2017), under direct quota. Out of these 26, one Sh. Harpreet Singh was appointed as Sr. Administrative Officer, DRDO whose technical resignation stands accepted vide Government Order No.32-Edu(Tech) of 2018 dated 16.03.2018.

Whereas, based on the directions of Hon'ble High Court in the above titled case and subsequently in the recent Court direction dated 23.09.2019 in the case titled Tawheeda Habib Vs State and Ors, the operative part of which is reproduced as under:

"In the above background, let respondent No. 03 Commissioner Secretary to Government, Technical Education Department ensure inclusion the name of the petitioner in the initial constitution as also notify her position in the final Seniority list at its appropriate place and thereafter ensure regular promotion of the petitioner against the post of Assistant Director from the date the post has become available held by the petitioner for further consideration/promotion. Till this exercise is completed, the respondents shall not make any promotion/fill up of the post of Assistant Director and Deputy Director".

Now, in view of the above, objections if any, to the inter-se placements in the list **Annexed as "A"** in case of In-service incumbents confirmed vide Government Order No. 30-Edu(Tech) of 2002 dated 05.03.2002 and direct recruits appointed through Public Service Commission from time to time and **"B"** in case of all I/c Superintendents, in-service or retired, are invited from the concerned officers, which shall be received in the Administrative Department, Civil Secretariat, Jammu within 15 days after publication of this tentative list. Objections shall be supported by substantial documentary proofs and objections received after the due date shall not be entertained.
