- Now therefore in view of the above:-
  - The candidature of the above mentioned 32 candidates (SAC-24, FC-08) at Para No. 01, who have failed to submit the requisite deficient document and candidature of one candidate namely Mohammad Yaqoob Bhat S/o Gh. Ahmad Bhat of SAC are hereby rejected. However, these candidates can file an appeal before the Appellant Authority of the Commission, as envisaged under Rule 31 of the J&K Public Service Commission (Business and Procedure) Rules 1980 at Commission's office, Jammu against their rejection within 10 days from the issuance of this notice, after which, no appeal, whatsoever, shall be entertained.
