**Subject: - Inclusion of name in the final seniority list of Medical Officer (Ayurvedic/Unani) of Indian Systems of Medicine Wing of Health Department as it stood on 01.12.2005.**

**NOTICE**

WHEREAS, vide Government Order No. 537-HME of 2005 dated 14.09.2005, a tentative seniority list of Medical Officers (Ayurvedic/ Unani) of Indian Systems of Medicine Wing of Health Department was notified and circulated among members of the services for inviting objections, if any, within a period of 30 days;

AND WHEREAS, some objections were received, which were examined in the department and necessary corrections as required under rules were made in the seniority list;

AND WHEREAS, vide Government Order No.664-HME of 2005 dated 07.12.2005, final seniority list of Medical Officer (Ayurvedic/Unani) of Indian Systems of Medicine Wing of Health Department as it stood on 01.12.2005 was issued;

AND WHEREAS, while preparing the proposal for regularization/ confirmation of Medical Officers (Ayd/Unani) as Assistant District Medical Officers, it came into the notice that Dr. Ghulam Nabi Rangraz, Medical Officer (Unani) was placed as ADMO (Unani) w.e.f. 08.09.2000, but his name did not figure in the final seniority list of Medical Officer (Ayurvedic/Unani) of Indian Systems of Medicine Wing of Health Department issued vide Government Order No.664-HME of 2005 dated 07.12.2005;

AND WHEREAS, Dr. Ghulam Nabi Rangraz, Medical Officer (Unani) figured at S.No. 114 i.e. below Dr. Chunni Lal, Medical Officer (Unani), who figured at S.No. 88 and above Dr. Masood Ahmad, Medical Officer (Unani) figured at S.No. 162 in the final seniority list of Medical Officers (ISM) as it stood on 01.01.1985;

AND WHEREAS, Dr. Rajeev Sharma, Medical Officer (Ayurvedic) has also represented in this Department to consider him for regularization/ confirmation as ADMO (Ayd) as he is posted as I/C ADMO Rajouri by the Director, Indian Systems of Medicines vide Order No. 846 dated 21.01.2021 and also figuring at S.No. 69 in the seniority list of Medical Officers (Ayd) issued vide Government Order No. 338-HME of 2012 dated 27.04.2012;
