Subject: Seniority list of the members of the Jammu and Kashmir Administrative Service (KAS), appointed to the service w.e.f 01.01.2004 to 01.12.2008.

Government Order No.316-JK(GAD) of 2021,
Dated:07-04-2021.

WHEREAS, a tentative seniority list of 239 officers (including two adhoc inductees), appointed to the Time Scale of the Jammu and Kashmir Administrative Service between 01.01.2004 to 01.12.2008, as it stood on 01.01.2010, was notified vide Government Order No. 485-GAD of 2010 dated 21.04.2010 for inviting objections;

AND WHEREAS, 110 representations were received against the said seniority list, in which substantial issues were raised, for examination of which, the Government appointed a three member Committee headed by Shri Verghese Samuel, IAS, the then Chairman, J&K Special Tribunal (now retired), vide Government Order No. 1076-GAD of 2010 dated 24.09.2010;

AND WHEREAS, the Committee submitted its report alongwith recommendations to the Government on 15.02.2011;

AND WHEREAS, while the issue of determination of seniority was under examination in the General Administration Department, some officers approached the Hon'ble High Court through the medium of writ petition bearing SWP No. 1215/2011;

AND WHEREAS, the Hon'ble High Court in its interim order dated 7.6.2011 directed as under:-

"The contention of the petitioners is that in terms of Rule 15(4) of the Jammu and Kashmir Administrative Service Rules, 2008, the seniority of the members of the feeding cadre into KAS is to be fixed from the date of their entering into service. The petitioners state that their services are to be governed strictly in consonance with the aforesaid rules but the



respondents are not fixing their seniority in terms of the aforesaid rule.

Notice in the CMP also as aforesaid.

In the meanwhile, it is provided that respondents shall consider the case of the petitioners for fixation of their seniority in terms of Rule 15(4) of the Jammu and Kashmir Administrative Service Rules, 2008. This order is, however, subject to objections from the other side";

AND WHEREAS, on examination, it was found that these petitioners were appointed to the Time Scale of KAS, in terms of the Jammu and Kashmir Administrative Service Rules, 1979 and not under the Rules of 2008 and, as such, there plea regarding fixation of seniority in terms of Jammu and Kashmir Administrative Service Rules, 2008 was found to be devoid of any merit or justification, and was, accordingly, rejected;

AND WHEREAS, the final seniority list of the officers appointed to the Time Scale of the Jammu and Kashmir Administrative Service between 01.01.2004 to 01.12.2008, as it stood on 01.01.2010, was notified vide Government Order No. 743-GAD of 2011 dated 24.6.2011. 15 days time was given for filing of review petition, in case any officer was aggrieved of his/her placement in the seniority list;

AND WHEREAS, various review petitions were filed which could not be disposed of, as a slew of writ petitions were filed, challenging therein the seniority list *ibid*. There were two groups of petitioners, one group seeking direction for the official respondents to fix the seniority strictly in accordance with proviso (i) to sub-rule (4) of Rule 15 of J&K Administrative Service Rules, 2008 and another group praying to declare proviso (i) to sub-rule (4) of Rule 15 of the Jammu and Kashmir Administrative Service Rules, 2008 as illegal and ultra-vires the constitution;

AND WHEREAS, the matter remained under adjudication for quite a long time and the Hon'ble Court was

pleased to issue various interim orders. Against one such interim order dated 13-02-2014, passed by the Hon'ble Division Bench, the Government filed an SLP before the Hon'ble Supreme Court, which vide order dated 22.01.2015 directed as under:-

"In so far as the grant of special scale is concerned, as an interim direction, by modifying the interim order passed by the Division Bench of the High Court, we direct the State of Jammu and Kashmir to allow the special scale as a matter of officiating arrangement, by strictly adopting the seniority list affirmed by the learned Single Judge in the judgment dated 8.11.2013.

Since the controversy in hand pertains to interim directions only, while disposing of the main special leave petition, we consider it just and appropriate to request the High court to dispose of the Intra-Court Appeal as expeditiously as possible and preferably within two months from the date a certified copy of this order is placed before the High Court";

AND WHEREAS, the appeal pending before the Hon'ble Division Bench was finally on 18.04.2016, with the following directions:-

"In the background of stated facts and circumstances, the judgment impugned is not sustainable, as such, is set aside. All the writ petitions, as decided by the common judgment impugned, are remanded for fresh adjudication. SWP No. 282/2012 is also required to be decided along with said petitions, therefore, respective pleadings in SWP No. 282/2012 shall be completed within four weeks i.e. respondents therein shall file counter affidavit within a period of two weeks with copy in advance to the learned counsel for the petitioner so as to enable him to file rejoinder, if any, thereafter within two weeks. In default, right to file of the defaulting party shall be deemed closed.



All the writ petitions decided vide common judgment impugned and also the SWP No. 282/2012 be listed for final hearing before the Writ Court (learned Single Bench) having the roster in the week commencing 23rd May, 2016 in the regular cause list";

AND WHEREAS, on 26.4.2016, the Ld. Single Bench in an application filed by Mr. Ashok Kumar and Ors directed as under:

"After considering the matter in entirety, I am of the considered view that in the circumstances, the competent authority may go ahead with the process of promotion/induction into the IAS, however, decision in respect thereof be not acted upon till the next date before the Bench and subject to objections by the other side. It is also clarified that if on account of administrative exigencies, officiating promotion etc. are required to be made, the competent authority would be at liberty to lay motion in respect thereto before this Court";

AND WHEREAS, while the matter was pending consideration before the Hon'ble Court, the Government appointed a five member Committee, headed by Mr. B.B. Vyas, IAS, the then Principal Secretary to the then Chief Minister (now retired), vide Government Order No. 203-GAD of 2017 dated 20.2.2017, for suggesting a road-map for resolving the seniority issue of members of Jammu and Kashmir Administrative Service;

AND WHEREAS, the Committee submitted its recommendation on 31.03.2017, which upon examination were found to be inconclusive, in view of which it was decided to constitute a fresh group of officers to work out the seniority list on a normative basis;

AND WHEREAS, the Government constituted another Committee of officers, headed by Mr. Hirdesh Kumar, IAS, the then Commissioner/Secretary to the Government, Social Welfare Department (now Chief Electoral Officer, J&K), vide Government

Order No. 440-JK(GAD) of 2020 dated 01.04.2020, which submitted its report on 16.05.2020;

AND WHEREAS, based on the principles laid down by the Committee, the seniority list of the officers appointed to the Time Scale of the Jammu and Kashmir Administrative Service between 01.01.2004 to 01.12.2008, as it stood on 01.01.2010, was notified vide Government Order No. 749-JK(GAD) of 2020 dated 05.08.2020, inter-alia inviting objections from the officers, if any aggrieved with the position assigned to him/her in the seniority list;

AND WHEREAS, the aforesaid seniority list was challenged before the Hon'ble Central Administrative Tribunal in two (02) OAS i.e. O.A. Nos 924 and 925/2020. In TA No. 3481/2020, the validity of Rule 15(4) of the Jammu and Kashmir Administrative Service Rules, 2008 was also challenged. Alongside, the writ petitions which were pending adjudication in the Hon'ble Single Bench of the J&K High Court were transferred to the Hon'ble CAT, upon re-organization of State of Jammu and Kashmir;

AND WHEREAS, the Hon'ble Central Administrative Tribunal heard these matters and disposed of the same vide Order dated 30.3.2021, which reads as under:-

- (a) T.A.Nos.3415, 3430, 3439, 3449, 3462 and 3467/2020, wherein the final seniority dated 24.06.2011, is challenged, are dismissed;
- (b) The O.A. Nos. 924 and 925/2020, and TA.No.3481/2020 are allowed
 - (i) setting aside the order dated 01.02.2000, constituting a committee to review the final seniority list dated 24.06.2011; and the Government order dated 05.08.2020, revising the final seniority list dated 24.06.2011; and



- (ii) holding that Rule 15 (4) of 2008 Rules and Clause (1) of the proviso thereof, are illegal and contrary to law;

AND WHEREAS, while disposing of the matter, the Hon'ble Central Administrative Tribunal has returned its findings, which are as under:-

- (i) The seniority list dated 24.06.2011 fully accords with the KAS Rules as well as general principles of reckoning the seniority.
- (ii) Sub-rule (4) of Rule 15 of KAS Rules is not valid.
- (iii) Though the promotions/appointments made against the leave and training reserve vacancies cannot be treated as invalid, such appointees/promotees cannot be placed above those, who are promoted/appointed against regular vacancies;

AND WHEREAS, the matter has been examined in consultation with the Department of Law, Justice and Parliamentary Affairs and it has been found that the operative part of the order dated 30.3.2021 passed by the Hon'ble Central Administrative Tribunal when read alongwith the principles laid down in the judgment on the issues framed by it, the seniority list of 2011, issued vide Government Order No. 743-GAD of 2011 dated 24.6.2011, fully accords with the KAS Rules as well as general principles of reckoning the seniority, except to the extent of modifying the seniority for placing appointees/promotees against leave and training vacancies below those, who are promoted/appointed against regular vacancies as per the principles of law laid down by Hon'ble Tribunal in its order *ibid*;

AND WHEREAS, on further examination, it has also been found as under:-

- (i) Some more officers have been inducted into the Time Scale of KAS during the year 2008 against the vacancies which did not exist as on 01.01.2008 and hence to be treated on par with the officers appointed/promoted against leave and training reserve vacancies. These officers will have to be placed below those officers, promoted/appointed to the Time Scale of KAS during the year 2008 against the vacancies allocable as on 01.01.2008;
- (ii) The dates of appointment to the KAS in respect of some officers figuring in the seniority list issued vide Government Order No. 743-GAD of 2011 dated 24.6.2011 have been reviewed and their seniority is re-fixed on account of which their names would not figure in the instant seniority list, as it relates to only those officers who have been appointed to the KAS w.e.f 01.01.2004 to 01.12.2008;
- (iii) The cases of some officers, with dates of induction into KAS after 01.12.2008, have been reviewed sequel whereof their appointment has been made with effect from 25.09.2008 and their inter-se-seniority fixed accordingly. Consequently they would form part of the instant seniority due to re-fixation of seniority order in their favour;
- (iv) In respect of some officers whose dates of induction into KAS were reviewed and decided as 25.9.2008, their inter-se-seniority



position upon such review could not be notified, as seniority list of 2011 was pending adjudication in the court of law. Their names are required to be included in the instant seniority list by assigning them appropriate seniority position as per the Jammu and Kashmir Administrative Service Rules, 1979 and the principles governing fixation of seniority;

- (v) The cases of four officers, namely; Mr. Mohammad Ashraf Bhat, Mr. Nazir Ahmad Lone, Mr. Mohammad Mushtaq Beigh and Mr. Nazir Ahmad Mir in respect of whom consideration for induction into KAS was deferred by the Establishment-cum-Selection Committee in its meeting held during the year 2008 on account of pending departmental enquiries were reviewed and effect of appointment given from 25.09.2008 by utilizing leave reserve and training reserve vacancies which were reserved for them. These officers are to be placed in the instant seniority list by assigning appropriate position as per the rules governing determination of seniority; and
- (vi) Three Junior Scale KAS officers of 2004 batch have been inducted into the Time Scale of KAS with effect from a date prior to the date when they would acquire eligibility for such appointment in terms of Jammu and Kashmir Administrative Service Rules, 1979, on 1.1.2009 by utilizing leave and training reserve vacancies. These officers will have to be assigned the seniority position in the ratio of 3:1 within the group of officers who have either been appointed/promoted against the



leave and training reserve vacancies or against the vacancies which did not exist on 1.1.2008 and would actually become available as on 01.01.2009.

NOW, THEREFORE, a seniority list of the members of the Jammu and Kashmir Administrative Service, appointed to the service between 01.01.2004 to 01.12.2008, as it stood on 01.01.2010, forming **Annexure A** to this order is hereby notified for information of all the concerned officers. This shall be without prejudice to the outcome of the writ petition(s), pending in any competent court(s) of law. The date of birth recorded in the seniority list shall in no manner be construed as final and shall be subject to verification from service-book/date of birth certificates of the concerned officers.
