Subject:-Guidelines/instructions on COVID containment measures in the Union Territory of Jammu & Kashmir, w.e.f. 31.05.2021 (Monday).

Reference: - 36-JK (DMRRR) of 2021 Dated: - 29.05.2021

ORDER No: - 12/DCJ of 2021 Dated: - 30-05-2021

- Whereas, State Executive Committee (SEC) vide Govt Order No 36-JK (DMRR) of 2021 Dated: -29.05.2021 has issued detailed guidelines/ instructions on COVID containment measures in the Union Territory of Jammu & Kashmir, w.e.f. 31.05.2021;
- Whereas, State Executive Committee (SEC) vide Govt Order No 35-JK (DMRR) of 2021 Dated: -29.05.2021 has categorized Jammu as Orange District, based on the assessment of total case load, test positivity rate, vaccination status of target population and compliance with COVID appropriate behavior;
- Whereas, a detailed review of the current COVID situation was conducted by the District Disaster Management Authority (DDMA), Jammu with respect to current positivity rate, hospital bed occupancy and total active cases;
- 4. And whereas, on the basis of above review, it has been felt that certain containment measures are required to be taken at a macro level in order to restrict the movement and inter mingling of people, thereby limiting the chain of transmission;

- 5. Now, therefore, in exercise of powers conferred under Section 144 of CrPC, read with National Disaster Management Act, 2005, I, Anshul Garg, IAS in my capacity as District Magistrate, Jammu do hereby issue following directions w.e.f. 31.05.2021 (7.00AM), till further orders: -
- I. The following activities shall be permissible/ allowed in entire District:
 - i. Chemists and Druggists, Diagnostic Centers, Medical, Optical and Clinical Establishments
 - ii. LPG Outlets and Petrol Pumps
 - iii. Vegetable & Fruit Markets, including street vendors
 - iv. Shops dealing with Milk & Milk Products, Meat & Chicken shops
 - v.Agricultural activities including establishments dealing with agricultural inputs, implements and tools
 - vi. Cattle feed and fodder shops
 - vii. Print & Electronic Media
 - viii. FCI and FCS&CA depots
 - ix. Operation and maintenance of telecom towers and other telecom infrastructure
 - ${\bf x}.$ e-Commerce & Home Delivery of essential goods and services
 - xi. Restaurants in Hotels for in-house guests, to be served only in rooms
 - xii. Kitchens in Restaurants and Food Outlets (only for Home Delivery)
 - xiii. Dhabas/Eateries and Canteens at Bus Stand, Railway Station, Airport and along the National Highways
 - xiv. All Industrial and Scientific establishments (both Public & Private)
 - xiv. All development, construction works and mining activities
 - . Interstate and intra state movement of essential goods

II. The Shops and Business Establishments across the jurisdiction of Jammu Districts shall open as per the schedule given below up to 5.00 PM daily: -

This roster/schedule shall be applicable to both Wholesale and retail establishments

- III. The roster for the Indoor Shopping Malls shall be notified separately after consultation with Management of these Malls
- IV. There shall be Daily Night Curfew from 8.00 PM to 7.00 AM next day
- V. There shall be Weekend Curfew w.e.f. 8.00 pm each Friday till 7.00 AM each Monday, with only permissible activities as mentioned at I above
- All other Guidelines and SOPs for Orange Category Districts as mentioned in Govt Order No. 36-JK (DMRRR) of 2021 Dated: - 29.05.2021 shall be applicable;
- 7. Any violation of the directions issued above shall invite penal action under the relevant provisions of Disaster Management Act, 2005. Since, it is not possible to serve prior notice of this order; it is as such being issued exparte.
