Subject: COVID-19 Management-Imposition of additional restrictions regarding.

ORDER

1. Whereas, this office has issued an order vide no. DCL/PS/COVID-19/00/2021-1074 Dated: 26-04-2021, wherein several restrictions have been imposed for effective containment and management of the COVID-19 Situation in the district.
2. Whereas, Secretary, Ministry of Health and Family Welfare, GOI, vide DO No. Z.28015/85/2021-DM Cell Dated: 25-04-2021 has advised all District Magistrates to undertake local containment measures to restrict intermingling amongst people so that spread of infection can be controlled.
3. Whereas, it has been observed that markets/shops can prove to be potential hotspots for spread of infections if adequate measures for containment are not taken.
4. Therefore, in view of the above, I, Shrikant Balasaheb Suse, IAS, District Magistrate, Leh in exercise of power conferred upon me as Chairman, District Disaster Management Authority under Section-34 of Disaster Management Act, 2005 as well as under Section-144 of CrPC, 1973, and Epidemic Disease Act 1897; hereby order that the different shops in Leh District shall open as per the schedule given below:

GROUP-I	
MONDAY, WEDNESDAY, FRIDAY	
1.	Groceries, Departmental Stores, Sweet Shops, Dry fruit Shops and roadside Dry fruit sellers.
2.	Gift Shops, Shops dealing with religious related items.
3.	Utensil & Crockery Stores, Toy Shops, Optical Facilities.
4.	Book and Stationery shops, Novel Stores, Typing and Printing Shops, Photostat Shops.
5.	Automobile Showrooms, Welding Shops.
6.	Wine Shops
7.	Cloth and Readymade Garment Shops, Home Furnishing items, Shoes & Chappal Stores.

GROUP-II	
TUESDAY, THURSDAY, SATURDAY	
1.	Mobile Shops, Electrical Appliances Shops, and Watch & Electric Repairs Shops, Cycle Shops, IT & Computer Shops.
2.	Boutiques, Tailor Shops, Hair Salons, Cosmetic Shops
3.	Furniture Showrooms and Stores
4.	Hardware, Cement & Building material Stores, Sanitary Goods Stores, Glass Houses, Shuttering materials.
5.	Jewellery Shops/Showrooms/Souvenir Shops etc.
6.	Any other Category not covered in Group-I and exempted categories.

- 5. All the business establishments shall remain closed on Sundays, except those falling in exempted category elaborated in the succeeding Para 6;**
6. The following categories of shops dealing with Essential Services & Perishable items shall fall under the exempted category (Allowed to Open Daily):
- I) Chemist Shops, Diagnostic Centers, Medical & Clinical Establishments etc.
 - II) Vegetable and Fruit Markets.
 - III) Milk Shops, Meat and Chicken Shops, Restaurants/Eateries (with 50% capacity), Nanwai Shops & Bakeries.
 - IV) Petrol Pumps & LPG Outlets.
 - V) Mechanic/Tyre repairing Shops.
7. The Sr. Superintendent of Police, Leh, Chief Executive Officer, DDMA (Addl. District Magistrate, Leh), and all Sub Divisional Magistrates in their respective Sub-Divisions shall ensure implementation of the above directives in letter and spirit.
8. These restrictions shall come into effect with from 03-05-2021.
9. Shop owners shall ensure COVID appropriate behaviors outside as well as inside the shops such as Wearing of Masks, Social Distancing norms, frequent washing/sanitization of hands, marking of circles outside the shops for queue management and shall avoid crowding in these establishments.
10. Any violations of these orders shall invite punitive action under Section-188 of IPC, Disaster Management Act, 2005 and Epidemic Disease Act 1897.
