Whereas, Health & Family Welfare Department vide letter No. HME/HRM/64/2019 dated 19.09.2019 referred 11 posts [OM:07, RBA:01, SC:01, ST:01, ALC:01] of Consultant in the discipline of Gynae & Obsts for selection of suitable candidates; **and**

Whereas, J&K Public Service Commission vide Notification No. 12-PSC (DR-P) of 2019 dated 01.10.2019 advertised the said posts for selection of suitable candidates; **and**

Whereas, Commission received 118 applications, which were scrutinized and 105 eligible candidates were called for interview; **and**

Whereas, the interview of the shortlisted candidates was conducted w.e.f. 09.08.2021 to 11.08.2021 with the assistance of experts; **and**

Whereas, one post under ALC category has left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who had appeared in the interview is enclosed as **Annexure-“A”** to this Notification.
