- 5. Only hard copies of the objections are to be submitted along with Bank Draft at J&K Public Service Commission, Resham Ghar Colony, Bakshi Nagar, Jammu/Solina, Srinagar, during working hours.

6. Objections not confirming to the prescribed format or submitted beyond the prescribed date shall not be entrained.
