Subject: J&K Combined Competitive (Preliminary) Examination held on 24th October, 2021 - **Instructions for candidates for filing objections to provisional answer key.**

1. Candidates shall only use one form for every objection. Any form containing more than one objection written on it shall be liable for rejection.
2. For more than one question candidates can use single Bank Draft (Rs.500/- per objection) and mention on its reverse side the question, series, etc. or any other details required.
3. Separate objections should be filed with separate Bank Draft for both the papers. Objections should not be clubbed for both paper(s) General Studies (I) and (II).
4. Copies of sources should be separately attached, duly page numbered and marked for the question referred and should be legible. Illegible and unmarked copies shall not be entertained.
5. Only hard copies of the objections are to be submitted along with Bank Draft at J&K Public Service Commission, Resham Ghar Colony, Bakshi Nagar, Jammu/Solima, Srinagar, during working hours.
6. Objections not confirming to the prescribed format or submitted beyond the prescribed date shall not be entertained.
