

Whereas, DMRRR, further informed that since the appointing Department/authority is Agriculture Department, therefore, in terms of Government Order No: 528-JK (GAD) of 2021 dated 21-06-2021, the selection list/recommendations of the candidate for the post of Field Assistant Grade-III, Field Supervisor Mushrooms and Assistant Store-Keeper are being forwarded for appointment and thereof verification of character and antecedents at this end. The term and conditions laid down in the Govt Order No: 528-JK (GAD) of 2021 dated 21-06-2021, are reproduced hereunder:

The appointing authority, on the receipt of attestation forms from the candidates, shall forward these forms with a covering letter (Sealed and market secret) in the form prescribed to the Government Order No: 528-JK (GAD) of 2021 dated 21-06-2021 directly to the CID headquarters for conducting verification of the character and antecedents of the selectees.

The CID shall conduct the verification of the character and antecedents of the selectees and forward the same to the requisitioned authority within one month from the date of receipt of the list of selectees. In case the verification process in respect of some candidates requires more time, the CID may seek another one month in respect of such candidates only while forwarding the completed cases. However, the entire

time period in the verification process should not be more than two months under any circumstances.

The appointing authority, on receipt of satisfactory verification report, issue the appointment order and the candidates in whose case the report is received at a later stage (after the part selection list is operated upon) shall on the receipt of a satisfactory verification report be appointed notionally from the date the earlier appointments are made.

In case of receipt of an adverse and on confirmation thereof by the state/Divisional/District Level screening committee, as the case may be, the appointment shall automatically stand cancelled without any notice.

- Cognizance of Govt Order No: 586-JK (GAD) of 2021 dated 07-07-2021 who states that S.O 194 dated 17-06-2020 shall also be applicable to all migrant employees appointed after 17th June of 2020 under the Hon'ble Prime Ministers Special Package.
- Govt Order No: 1003-JK (GD) of 2021 dated 27-09-2021 regarding amendments in the Jammu and Kashmir Civil Services (Verification of character and Antecedents).
- Verification of Migrant/Category/Domicile status from the competent authority.

Whereas, the General Administration Department vide Order No: 1003-JK (GD) of 2021 dated 27-09-2021 while amending the Jammu and Kashmir Civil Services (Verification of character and Antecedents) Instructions, 1997 notified vide Government Order No: 1918-GAD of 1997 dated 09-12-1997 ordered to insert the following Paras ahead of the Para Ist of the instructions 2 of the Jammu and Kashmir Civil Services (Verification of character and Antecedents) Instructions, 1997

- 1. The candidates whose recommendations is released by the Selection agency shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate (s) shall forego their right to appointment forthwith.
- 2.In respect of selection lists already published, the period of 21 days shall be reckoned from the notification of these instructions.
- 3. The selection agencies shall also incorporate instructions mentioned at Para I above in all selection lists and ensure wide publicity to the recommendations for selection through their website and print/electronic media.

Whereas, Administrative Department vide office communication No: Agri/Coord/151/2021 dated 15-10-2021 asked this office to take further necessary action in the matter under rules, besides, all the quoted instructions/references as mentioned by DMRRR in the above said letter be taken into account while issuing the appointment orders in favour of the selected candidates.

Whereas, the verification Rolls of selected/recommended candidates were sent on to Additional Director General of Police (CID) for verification of antecedents vide communication No: Agri/Esstt/NG/2021-22/5025 dated 20-10-2021, Agri/Esstt/NG/2021-22/5038 dated 21-10-2021 and No: Agri/Esstt/2021-22/3857 dated 21-10-2021 who in turn vide communication No: CID/VB/2021/Fin/10373-74 dated 22-10-2021, CID/VB/2021/10371-72 dated 22-10-2021 and CID/VB/2021/Fin/10375-76 dated 22-10-2021 conveyed,

"Overall assessment is that they can be granted provisionally security clearance for the purpose of issuing appointment orders and hence such provisional security clearance is conveyed in respect of following candidates and an undertaking to the effect that they have no criminal records and also not facing criminal proceeding in any court of Law".


