Whereas, final seniority list of Livestock Development Officers of Animal Husbandry Department as it stood on 01.07.2005 was issued vide circular No. AH-1/2004 dated 07.07.2005 in favour of those officers who have been regularized till 01.05.2000;

Whereas, after that on the recommendations of the J&K Public Service Commission, Srinagar vide letter No. PSC/DPC/Rept/15/2016 dated 27.05.2019 the department regularized the services of (33) thirty three officers as Livestock Development Officers vide Government order No. 75-ASH of 2019 dated 11.06.2019 where under I/C Livestock Development Officers have been regularized w.e.f. 01.05.2000 to 01.05.2005;

Whereas, the department has not regularized the services of I/C Livestock Development Officer on the recommendations of J&K Public Service Commission from 2005 up to 2019, nor the department has issued any final seniority list of Livestock Development Officer after the issuance of seniority list of 2005;

Whereas, it has become expedient to notify the seniority list of these thirty three Livestock Development Officers of Animal Husbandry Department, who have been regularized vide Government order No. 75-ASH of 2019 dated 11.06.2019.


