Subject: Tribal Research Fellowships – Selection of Candidates.

Whereas, vide this office Notification No. TA-Plng/95/2021-03-TAD, dated: 27-12-2021, applications were invited by the Tribal Research Institute J&K, for award of Fellowships in respect of 14 Projects;

Whereas, one Fellow and an Associate Fellow was to be selected in respect of these 14 Projects;

Whereas, a large number of candidates applied for these fellowships through the mode as prescribed in the aforementioned notification;

Whereas, on scrutiny of the applications it was found that a total number of **560** applicants have applied for the award of these fellowships;

Whereas, some duplicate entries were also found to have been received but only one suitable entry was considered;

Whereas, further scrutiny of the applications revealed that only **472** applicants are possessing prescribed qualification/experience in the relevant field while **88** applicants are either not possessing requisite qualification or have simply forwarded a marks sheet without mentioning anything regarding their area of interest;

Whereas, vide this office Notification No. **TRI/JK/2021-22/18-20, Dated: 19-01-2022** a list of 472 applicants who were provisionally found to be in consideration zone for award of these fellowships and 88 rejected applicants was published in the leading newspapers and publicity of the same was also done through social media platforms;

Whereas, in response to the aforementioned Notification some aggrieved candidates registered their grievances and each of the grievance was perused, a gist of the same is produced as under:

S.No	Name of the Candidate	Grievance	Remarks
01	OVAIS JAVEED	Candidature rejected	Candidature was rejected as the candidate simply forwarded his CV and no documental proof was attached. Since the candidate has clarified and submitted the requisite documents in support of his claim hence his candidature has been considered.
02	Dr. TAWSEEFBHAT	Candidature not considered	Name of the candidate is existing at S.No 452 of the list published in the media.
03	KAHKESHAN SHANAZ	Name Missing	Since the candidate submitted the details on 13th January 2022, however, last date for submission of details was 05th January 2022, hence her candidature was not considered.
04	SAMIYA GUL	Higher Qualification	The candidate represented with the plea that she is possessing Higher qualification but the same has not been considered. Since, the candidate has produced the proof of having Higher qualification, hence the same has been considered.
05	UMAR FAROOQ	Candidature not considered	Name of the candidate is existing at S.No 184 of the list published in the media.
06	IQRA BASHART QURESHI	Experience and publications not considered.	The candidate has submitted proof in support of her claim and the same has been considered.

07	Dr. SHAFIQA GUL	Candidature not considered	A perusal of the record reveals that the candidate had applied jointly with another candidate and that was the reason her case could not be considered. Now since the candidate has clarified her position and record also reveals the same hence her candidature has been considered.
08	ZAHOOR MANZOOR	Not considered but two more candidates with same qualification have been considered.	The desired qualification for this project was Degree in Water Supply, Sanitation and Hygiene. A perusal of the record reveals that none of the candidate is possessing Degree in this field, hence the committee has decided not to offer fellowship to any candidate in this field as no suitable candidate is available.
09	MUZAFFAR AHMED MALLA	Degree not considered	The candidate submitted his Degree Certificate and it has been found that the candidate is having a valid degree, hence his candidature has been considered.
10	RAQIB AHMAD DAR	Application not considered	A perusal of the record reveals that though the candidate forwarded his CV and documents but there was no application and also in the mail there was no mention of the Project for which the candidate has applied. Since the candidate has clarified his position and mentioned that inadvertently he could not mention the name of the project and now he has done the needful, hence his candidature has been considered.

Whereas, vide Government Order No. 43-JK (TRI) of 2022, Dated: 18-01-2022 a committee comprising of Officers/Officials was constituted for scrutiny and finalization of fellowships as per the criteria prescribed in the Notification;

Whereas, after considering the qualification and experience in the relevant field the committee recommended the names of the following candidates for selection as Fellow and Associate Fellow as mentioned against each project:

The fellowship shall be governed by the following terms and conditions:

1. The fellowship shall be for a period of 06 months only.
2. The candidate(s) shall report to the office of the Director Tribal Research Institute, J&K for joining by or before 10-02-2022.
3. The stipend shall be payable to the Fellow/Associate Fellow as per the remuneration mentioned in the notification.
4. After successful completion of field work the selected Fellow/Associate Fellow shall submit the detailed report including presentation, research work, publication, documentation etc.

5. The selection of the Fellow/Associate Fellow shall be provisional and subject to the production of Original documents to be submitted at the time of joining.
6. Each of the selected candidate(s) shall have to submit the monthly work done report to the office of the Director Tribal Research Institute, J&K.
7. The release of stipend in favour of the selected candidate shall be subject to the satisfactory work and conduct of the Fellow/Associate Fellow.
8. The usage and ownership rights of the research work, report generated, data captured during the fellowship period shall vest with the Tribal Research Institute, J&K.
