Notification

Whereas section 2, sub-section 'f' of Panchayati Raj Act, 1989, empowers Election Authority to determine the halqa area comprising a village or such contiguous number of villages and sub-section 'g' further explains that the halqa shall be determined in such a manner that the population of any halqa does not ordinarily exceed 3000 in hilly areas and 4500 in plain areas and sub-section 2 'cc' of section 56-D, empowers the Election Authority to determine and delimit Halqa Panchayat in accordance with this Act;

Whereas for the purpose of holding general elections under Panchayati Raj Act, 1989 in the year 2017, the power to determine and delimit Halqa Panchayats in accordance with this Act has been vested in the Chief Electoral Officer, J&K;

Whereas some proposals were received which were put in public domain vide Notice published vide No. 5411/CEO/Pyt/2017/798-826 dated 20-02-2017 and Notice No.5402/CEO/Pyt/2017/740 dated 01-09-2017 for inviting objections if any;

Whereas an objection has been received objecting to the inclusion of Gagardani in Panch Constituency Sransoo/Chaimullah-VII of Panchayat Halqa AN-246 Sransoo;

Whereas on examination, the said objection has been found to be justified and therefore it has been decided not to include Gagardani area in the Panchayat Halqa AN-246 Sransoo (Panch Constituency Sransoo/Chaimullah-VII).

Now, therefore, by virtue of this notice, the Election Authority under Panchayati Raj Act, 1989 (Chief Electoral Officer, J&K) do hereby notify the list of new Panchayat Halqas/Halqa Panchayat involved in delimitation/rationalization of Jammu Division as Annexure 'A2' & 'A3' and of Kashmir Division as Annexure 'B2' & 'B3'. The details of the same Halqa Panchayats are also available on the official website of Chief Electoral Officer, J&K @ www.cejco.jk.in.
