**Subject:-** Filling up of vacant seats of BAMS in JIAR, Jammu in pursuance of Orders of the Hon'ble High Court dated 20-12-2018 in the Contempt Petition No. CPOWP323/2018 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others .

### NOTIFICATION NO.002-BOPEE OF 2019 DATED 02-01-2019

In pursuance of Notification No. 121-BOPEE of 2018 dated 22-12-2018, and in compliance and with due deference of the orders of the Hon'ble High Court dated 20-12-2018 in the Contempt Petition No. CPOWP 323/2018 arising out of OWP No. 2208/2018 titled Jammu Institute of Ayurveda & Research Vs Union of India & Others, the counselling for the BAMS seats in JIAR held on 26-12-2018 in the Board Office at Srinagar/Jammu. Consequent upon the shortfall conveyed by the College as notified also by the Board vide Notification No. 125-BOPEE of 2018 dated 31-12-2018, the counselling for the said seats was held on 02-01-2019 in the Board Office at Srinagar/Jammu, based on which the list of candidates **provisionally recommended** for admission in the BAMS course JIAR is given in the **Annexure Á'** to this Notification.

The candidates so admitted shall have to join the Institution/Courses latest by **3<sup>rd</sup> of January, 2019 (4.00 p.m)**. The College shall, however, allow the candidates to join the Institution only on production of all original certificates as notified earlier from time to time.

The College shall submit the list of admitted candidates to the BOPEE on **03-01-2019 by 5.00 p.m.** alongwith the documentary evidence of the fee paid by the candidates for record and reference of the Board.

The other terms and conditions shall remain the same as notified from time to time.

As notified vide Notification No. 121-BOPEE of 2018 dated 22-12-2018 and Notification No. 123-BOPEE of 2018 dated 27-12-2018, the counselling/admission shall be purely provisional and subject to such other orders as may be passed by the Hon'ble High Court /final outcome of the writ petition No. 2208/2018 tiled Jammu Institute of Ayurveda & Research Vs Union of India & Ors. pending before the Hon'ble High Court at Jammu. The writ petition has been filed by the College against the orders of the Ministry of AYUSH dated 26-09-2018 vide which permission to undertake admission to BAMS/MD/MS Ayurveda



Courses in JIAR has been withdrawn by the Government of India. The said order has been stayed by the Hon'ble High Court but the final orders are yet to be passed by the Hon'ble High Court.

The orders of the Hon'ble High Court dated 20-12-2018, have been read in detail to the candidates during the process of counselling.

In pursuance of the orders of the Hon'ble High Court dated 20-12-2018, the College was directed to submit an undertaking before the Hon'ble High Court that in case the Government, based upon the Statutory Committee report, as mentioned in para 11(a&b) of the said order, withdraws the recognition the entire fee paid by the candidates shall be refunded along with such other amount which the Court may determine to compensate the candidates for the loss of their academic year. In case the College submitted the undertaking before the Hon'ble High Court a copy of the same should also be forwarded to the BOPEE for record and reference.
