**Subject:- Notice under Section 21 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 to the interested persons for the land measuring 91 Kanal 13 Marlas local (56 Kanal 19 Marlas) ordinary at village Channa, Tehsil Chassana, District Reasi to be acquired for construction of Budhal-Mahore-Gool GREF Road.**

Whereas, Officer Commanding 110 RCC (GREF) C/o 56 APO had placed an indent vide **No. 2010/LA/BMG/82/E2 dated: 28-11-2019** for acquisition of land for public purpose namely for construction of **Budhal-Mahore- Gool GREF road at village Channa Tehsil Chassana District Reasi;**

Whereas, on the identification of the indenting department revenue papers and map of land measuring **91 Kanals 13 Marla's** situated in village Channa of Tehsil Chassana District Reasi were got prepared by the field staff of revenue department through Tehsildar Chassana;

Whereas, vide this office No. SDM/M/2022-23/42-45 dated: 06-04-2022 District Collector, Reasi was requested to accord exemption from undertaking Social Impact Assessment study under section 9 read with section 40 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013 for acquisition for land measuring 91 Kanal 13 Marlas as the project affects the security and strategic interest of the State/UT;

Whereas, appropriate authority i.e Deputy Commissioner Reasi was pleased to accord exemption from undertaking SIA vide No. DC/Rsi/SQ/22-23/996-1000 dated: 19-05-2022;

Whereas, notification under Sub-Section (1) of section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 2013 was issued by this Collectorate vide No: CLA/SDM/2022-23/179-193 dated: 18-06-2022 which was served upon the land owners, interested persons and intending department, who were asked to file their objection/objections if any within 60 days from the date of issuance/publication of the notification;

Whereas, no such objection(s) has/have been received in this Collectorate in response to the above quoted notification;

Whereas, this Collectorate vide letter No. CLA/SDM/M/2022-23/507-09 Dated: 20-01-2023 requested the appropriate authority i.e. Deputy Commissioner, Reasi to issue declaration under section 19 of the act to the effect that land measuring 91 Kanal 13 Marlas local (56 Kanal 19 Marlas) ordinary (excluding Forest/State land) at village Channa, Tehsil Chassana, District Reasi is required for public purpose namely "**Construction/Improvement of Budhal-Mahore-Gool GREF Road**";

Whereas, vide notification No. 04 DC (Rsi) of 2023 dated: 01-02-2023 issued under endorsement No. DC/Rsi/SQ/22-23/9120-25 Dated: 02-02-2023 the Appropriate authority i.e Deputy Commissioner Reasi was pleased to issue deceleration under section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for land measuring 91 Kanal 13 Marlas local (56 Kanal 19 Marlas) ordinary situated at village Channa, Tehsil Chassana, District Reasi for public purpose namely

"Construction/improvement of Budhal-Mahore-Gool GREF Road" and copy of the same was endorsed to this office with the directions to follow all the provisions of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, LB-10 of 1980 and any other law governing the subject matter while making apportionment of compensation in favour of the rightful claimants of the below said land.

Therefore, the owners/all interested persons are hereby called upon to attend this office either in person or by an authorized agent or advocate within 35 days from the date of publication of this notice i.e. on or before 08-06-2023 during office hours at Collector Land Acquisition (SDM) Mahore to state their respective interests in the land, the amount, particulars of their claims to the compensation for such interests and to the measurement of land, if any.


**No claim will be entertained after the expiry of this period.**
