Notification 05 Of 2023 date: 06-10-2023

Subject : Merit list and Select List regarding engagement of Sanginis (AWWs).

Whereas vide this office Advertisement Notice No. 01 of 2023 dated: 13-05-2023, applications Forms from eligible female candidates were against 55 vacant posts of Sanginis (AWWs) of Poshan Project Billawar.

Whereas, the rectification regarding actual Ward No. of AWC Tilla-A has been made vide Corrigendum No. CDPO/Poshan/B/41-44/23 dated 27.05.2023

Whereas, 01 post of Sangini at AWC Dungara-A has been Kept withheld due to typographical error in location of Ward number of Anganwadi Centre vide corrigendum No. CDPO/Poshan/B/255-70/023 dated 29.05.2023.

Whereas, the further rectification regarding correction in name of Panchayats (Dhamlar, Kohag, Phangal and Batheri) have been made vide Corrigendum No. CDPO/Poshan/B/286/23 dated 02.06.2023.

Whereas, the selection for 05 posts of Sanginis against the AWCs namely AWC Kharari, AWC Makwal A, AWC Manoa A, Dungara-A and AWC Sray have not been finalized in compliance to order of Hon'ble High Court of J&K and Ladakh issued vide WP (C) 1532/2023 & WP (C) 1442/2023.

Whereas, 01 post of Sangini for AWC Dungara-A was kept withheld vide corrigendum No. CDPO/Poshan/B/255-70/023 dated 29.05.2023 before the issuance of Order of Hon'ble High Court of J&K and Ladakh issued vide WP (C) 1532/2023.

Whereas, 292 candidates have applied against remaining 50 available Vacant posts of Sanginis (AWWs) in Project Billawar.

Whereas, the merit and other necessary particulars of all the candidates were scrutinized/checked on 14-08-2023 by the committee constituted vide Govt. Order No. 103-JK(SWD) of 2023 dated 28-04-2023 & Govt. Order No. 222-JK(SWD) of 2022 dated 30-11-2022.

Whereas, vide this office Notification No. 03 of 2023 dated 29.08.2023 the provisional /tentative merit list and provisional /tentative select list regarding engagement of Sanginis have been published in State Times dated 31.08.2023.

Whereas, the copy of the provisional/tentative merit list and provisional /tentative select list was provided to Sarpanchs/Panchs/Councillors concerned and also posted at other locations as mentioned in above referred Govt. Orders.

Whereas, the Provisional/Tentative Merit List and Provisional/Tentative Select List were issued with necessary riders/observations put against the 118 candidatures of some of the candidates by the Selection Committee.

Whereas, after the expiry of 10 days from the date of publication of Notification No. 03 of 2023 dated 29-08-2023 in State Times dated 31.08.2023, the riders/observations of 23 candidates were omitted/excluded in Provisional Merit List and Provisional Select List by the Selection Committee after receiving necessary/requisite documents/ re-verification of ward residence proofs from applicant/ADC Billawar.

Whereas, after the expiry of 10 days from the date of publication of this Notification No. 03 of 2023 dated 29-08-2023 in State Times dated 31.08.2023; 05 grievances/objections have been received by the Office (CDPO Billawar - Member-Secretary Selection Committee for Sanginis) within the prescribed time limit which are disposed off by the selection committee.

Whereas, vide this office letter No. CDPO/Poshan/B/878-84/23 dated 04-10-2023 the merit list comprising of total 197 candidates for different AWCs and select list comprising of 50 candidates for 50 posts of Sanginis were submitted for approval to Additional District Development Commissioner Kathua as per above referred Govt. orders.

Whereas, the selection list was approved by Additional District Development Commissioner Kathua vide letter No. ADDC/K/8/2023-24/2335-38 dated 05-10-2023.

Therefore in view of the above and as per the procedure laid in the above referred Govt Orders, the Merit List and the Select List as Annexure-A and Annexure-B respectively are hereby published for the information of general public and all concerned.

Grievance(s)/Objection(s)(if any), the appeal in this regard shall lie before Deputy Commissioner Kathua within 10 days from the date of publication of this notification/list. No grievance(s)/Objection(s) of any kind shall be entertained after ten days from the date of issuance of this notification/list.
