**Subject:- Demand for Shifting of Jurisdiction of Latti Block from Munsif Court Ramnagar to Munsif Court Chenani. Submission of proposal thereof-**

Sir,

It is to bring into your kind notice that during the various Public Darbars held under the chairmanship of Administrative Secretaries visiting Panchayat Dudu and Latti, Block Latti Marothi, District Udhampur and during my visit on 31.05.2024 to Sub Division Dudu-Basantgarh, general public including ex PRIs raised the demand for shifting the territorial jurisdiction of Latti area from the Munsif Court Ramnagar to Munsif Court Chenani as the public is facing a lot of hardships especially during the winter and rainy season as the area remains mostly cut off from Ramnagar. Pertinent to mention here that, during the rainy and winter seasons, the public has to travel 4-5 hrs to cover approx 200 km of distance via Udhampur to reach Ramnagar to attend the judicial court at Ramnagar. The public further demanded for the shifting of Judicial Cases of Police Station Latti from the jurisdiction of Munsif Court Ramnagar to the Jurisdiction of Munsif Court Chennai.

In this context, it is requested that possibility for shifting territorial Jurisdiction of Latti Area from the Munsif Court Ramnagar to the Munsif Court at Tehsil Chenani be explored, so that long pending demand of the public is redressed.
