Terms of Reference:

- To monitor and advise the Union territory Government and local authorities for effective implementation of the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013;
- ii. To co-ordinate the functions of all concerned agencies;
- iii. To look into any other matter incidental thereto, or connected therewith, for implementation of above said Act.
- iv. To meet at-least once in every six months and observe such rules of procedure in regard to the transaction of business at its meetings as may be prescribed.

Terms of Reference of Vigilance Committee(s):

- To advise the District Magistrate/Sub-Divisional Magistrate, on the action which needs to be taken to ensure that the provisions of this Act or of any rule made there under are properly implemented;
- ii. To oversee the economic and social rehabilitation of manual scavengers;
- iii. To co-ordinate the functions of all concerned agencies with a view to channelize adequate credit for the rehabilitation of manual scavengers;
- iv. To monitor the registration of offences under this Act and their investigation and prosecution.
- v. To meet at least once in every three months.
