Subject: Posting of Lecturers of School Education Department awaiting adjustment.

Government Order No. 318 -JK (Edu) of 2024.

Dated: 12.08.2024.

Whereas, 14 I/c lecturers in various disciplines who were regularized by the DPCs held on 15.07.2019 and 11.08.2021, but their posting is still awaited due to the reason that they have pursued their PG qualification, without seeking permission from the Administrative Department (Competent Authority); and

Whereas, the regularization orders so issued, were subject to certain conditions among which one condition was that the genuineness of PG degree certificate/Institutions from where the degree has been acquired shall be ascertained by the concerned Directorates, keeping also in view the UGC guidelines issued from time to time regarding validity of the degrees and that the degree has been acquired after availing leave and proper permission from the competent authority; and

Whereas, after issuance of regularization orders, some Lecturers represented before the Department for their posting/adjustment as Lecturer; and

Whereas, the case was examined in the Department and vide Government Order No. 188-JK(Edu) of 2024 dated 15.03.2024, Department has extended one time exemption in favour of teaching/other staff of School Education Department who have acquired higher qualification during service through distance mode/online mode without prior permission from the Administrative Department; and

Whereas, as per the aforesaid Government order, two divisional level, Committees have been constituted at Directorate levels to verify the genuineness/equivalence of PG degrees acquired through distance mode/online mode during the service and eligible candidates will be considered after clearance by the designated committees; and

Whereas, the Department vide letter dated 26.04.2024 forwarded the list of lecturers forming Annexure-A and B to Director, School Education, Kashmir for taking further necessary action in terms of Government Order No. 188-JK(Edu) of 2024 dated 15.03.2024 ; and

Whereas, the Director, School Education, Kashmir vide letter No. DSEK/Estt-III/B.Trs/HRM/OTE/02/Gaz/700 dated 20.07.2024 has furnished the

recommendations of the designated committee and have been recorded in the remarks column against each ; and

Now therefore, in light of recommendations from the designated Committee, following Lecturers are hereby posted/adjusted in the institutions, against available vacancies, as shown against each:-
