### Government Order No.:428-JK(GAD) of 2025 Dated:03.04.2025

Sanction is hereby accorded to the constitution of Monitoring Committee for the Eco-sensitive Zones of Dachigam National Park, Overa-Aru Wildlife Sanctuary and Thajwas Wildlife Sanctuary, for effective monitoring of the provisions of notification S.O. 1553 (E), dated 14<sup>th</sup> September, 2006, of the erstwhile MoEF, Government of India, and Committee for suggesting the environmental safeguards/measures for new construction of hotels and resorts which shall form component of Tourism Master Plan for Eco-Sensitive Zone of Dachigam National Park, Overa-Aru Wildlife Sanctuary and Thajwas Wildlife Sanctuary, with the following composition and terms of reference:

#### Terms of reference:-

- i. The Monitoring Committee shall, based on the actual site specific conditions, scrutinize the activities that are covered in the Schedule to the notification of erstwhile Ministry of Environment and Forest, Government of India, No. S.O. 1553 (E), dated 14<sup>th</sup> September, 2006, and are falling in the Eco-sensitive Zone, except for the prohibited activities as specified in the Table under paragraph 4 thereof, and referred to the Central Government in the Ministry of Environment, Forest and Climate Change or the State Environment Impact Assessment Authority, as the case maybe, for prior environmental clearances under the provisions of the said notification.
- ii. The activities that are not covered in the Schedule to the notification of the erstwhile Ministry of Environment and Forest, Government of India, No. S.O. 1553 (E), dated 14<sup>th</sup> September, 2006, and are falling in the Eco-sensitive Zone, except for the prohibited activities as specified in the Table under paragraph 4 thereof, shall be scrutinized by the Monitoring Committee based on the actual site-specific conditions and referred to the concerned Regulatory Authorities.
- iii. The Member Secretary of the Monitoring Committee or the concerned Collector(s) or the concerned Deputy Conservator of Forests shall be competent to file complaints under section 19 of the Environment (Protection) Act, 1986 against any person who contravenes the provisions of this notification.
- iv. To invite representatives or experts from concerned Departments, representatives from industry associations or concerned stakeholders to assist in its deliberations depending on the requirements on issueto-issue basis.
- v. To submit the annual action taken report of its activities as on 31st March of every year by 30th June of that year to the Chief Wildlife Warden in the state as per proforma appended at Annexure V to the Notification.
- vi. The Central Government in the Ministry of Environment, Forest and Climate Change may give such directions, as it deems fit, to the Monitoring Committee for effective discharge of its functions.

- i. To suggest the environmental safeguards or measures for new construction of hotels and resorts, which shall form a component of the Tourism Master Plan.
- ii. To put in place a risk assessment study on landslide, slope stability and seismicity and recommend environment friendly and safe construction measures to be adopted.
