Subject: Extension of the timeline of the Financial Assistance of West Pakistani Refugees (WPRs) settled in the UT of Jammu and Kashmir from 31.03.2024 to 31.03.2025 under the Rehabilitation Package approved by Cabinet on 30.11.2016.

Whereas Government of J&K adopted the Scheme approved by the Ministry of Home Affairs, Government of India for providing Financial Assistance to 5764 West Pakistani Refugees (WPRs) families settled in the UT of Jammu and Kashmir and notified the same vide Government Order No.57-DMRRR of 2018 dated 11-10-2018, the timeline of the scheme has been extended from time to time and the sunset date of the scheme was notified as 31.03.2025; and

Whereas, Ministry of Home Affairs, Government of India vide communication No. 12013/01/2020-J&K Dated 21.03.2025, has conveyed approval to the extension to the timeline of the scheme for providing Financial Assistance to West Pakistani Refugees (WPRs) settled in Jammu and Kashmir from 01.04.2025 to 31.03.2026 under the Rehabilitation package already approved by MHA on 13.06.2018.

Accordingly, sanction is hereby accorded to the extension of timeline of the scheme for providing Financial Assistance to West Pakistani Refugees (WPRs) families settled in Jammu & Kashmir, from 01.04.2025 to 31.03.2026 within the approved outlay of Rs. 317.02 Crore with the stipulation that the scheme shall not continue beyond sunset date i.e. 31.03.2026.
