Subject:- Regular Departmental Action against Mr. Gulzar Ahmad Malik S/o Mohammad Ibrahim R/o Sonpah Beerwah, Budgam, the then Patwari Halqa Arizal, Khansahib in case FIR No. 35/2021 u/s 7 of PC Act, Samvat 1988 P/S Anti Corruption Bureau, Srinagar - imposition of penalty thereof.

Order No. 40 - FC (Revenue) of 2025.

1. Whereas, Gulzar Ahmad Malik S/o Mohammad Ibrahim R/o Sonpah Beerwah, Budgam, the then Patwari Halqa Arizal, Khansahib was trapped and arrested by ACB on 08.11.2021 for demanding and accepting the bribe amount of Rs. 2000/- from complainant for effecting entries in revenue records in respect of land measuring 1 kanal purchased by the Complainant's wife and the accused official was placed under suspension vide order No. THH/WBN/20-21/773-76 dated 09.11.2021; and
2. Whereas, Revenue Department vide communication No. REV-Vigl/11/2023(7121823) dated 14.02.2023, has enclosed the prosecution sanction accorded vide Govt Order No 10-JK-GAD(Vig) of 2023 dated 30-01-2023 Srinagar with request to initiate regular departmental action against the accused official; and
3. Whereas, the case of the accused official was further referred to Divisional Commissioner, Kashmir vide letter dated 27.03.2023 with request to initiate Regular Departmental Action (RDA) against the then Patwari, Gulzar Ahmad Malik , the then Patwari Arizal, Khansahib ;and
4. Whereas, in order to initiate RDA against the officials under suspension, Deputy Commissioner, Budgam vide Order No. DCB/Estt/70 of 2023 dated 02.11.2023 constituted a committee headed by Additional Deputy Commissioner, Budgam to examine the matter, frame the charge sheet and statement of imputation; and
5. Whereas charge sheet was served upon Mr. Gulzar Ahmad Malik, the then Patwari Halqa Wahabpora, Budgam vide No.DCB/Estt/23/897 dated 20.11.2023 and the official replied to the charge sheet denying the charges levelled ;and
6. Whereas, Deputy Commissioner Budgam appointed Assistant Commissioner, Revenue, Budgam as Inquiry Officer vide order No. DCB/SM/Estt/23/1105 dated 18.12.2023; and



7. Whereas, after conducting detailed Inquiry, the Inquiry Officer submitted Inquiry Report vide letter No DCB/Estt/SM/2024/33-34 dated 22.04.2024, concluding therein:

"...during the course of enquiry reveals that exchange of some amount (money) has taken place and the same has been recovered from Chokidar concerned."

8. Whereas, the case of the official has been examined and upon consideration of all relevant aspects, the Competent Authority (Financial Commissioner Revenue), has found the official guilty of misconduct as charged, and, taking into account the gravity of the misconduct decided to impose the penalty as under:-

a. "Three increments shall be with-held with consequential effect on promotions.

b. He shall not be assigned any sensitive posting for next 5 years".

Now, therefore, In terms of Rule 30 of J&K Civil Services(Classification Control and Appeal) Rules, 1956, the penalty as above is imposed upon Mr. Gulzar Ahmad Malik S/o Mohammad Ibrahim R/o Sonpah Beerwah, Budgam, the then Patwari Halqa Arizal, Khansahib.
