In the interest of administration, Mr. Mohammad Usman Khan, JKAS, presently awaiting orders of adjustment in the General Administration Department, J&K, is hereby transferred and his services are placed at the disposal of the Union territory of Ladakh, on deputation basis, with immediate effect.

It is further ordered that:-

- (i) the deputation of the above officer shall be for a period of two years or till he is recalled.
- (ii) the lien and promotion prospects of the officer shall remain with General Administration Department, J&K.
- (iii) he shall be entitled to avail incentives as may be made available in due course of time by the UT of Ladakh; and
- (iv) he shall be deemed to have been relieved with immediate effect with the directions to report to the General Administration Department, Union territory of Ladakh, for further posting.
