Supplementary DV for the left-out candidates was also conducted vide Notice No. JKSSB-COEEXAM(UT)/11/2025-03(7655961) **dated 15.06.2025;** and

Whereas, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide **Order No.221-SSB of 2025 dated 14.07.2025** and the selection stands framed by the Selection committee strictly in accordance with the indent received from the Indenting Department. It is pertinent to mention that the horizontal reservation in this particular selection could not be implemented due to less number of posts in the items for the block as required for ESM and PwDs; and
