- ii. Strict enforcement measures including closure or relocation of non-complaint units, in coordination with Urban Local Bodies, Municipal Corporations, Pollution Control Board and law enforcement authorities.
 - iii. Institutionalization of the compliance monitoring mechanism with quarterly reports to be submitted to Director General of Civil Aviation, Government of India.


