The above arrangement of Associate Professors as Incharge Principals on look after basis shall be subject to the following terms and conditions:

1. That the arrangement shall not confer any preferential right on the Incumbents to claim preferential treatment for their promotion, which shall be made in accordance with the provisions of Jammu and Kashmir Education (Gazetted) College Service Recruitment Rules, 2014 or when the Competent Authority approve the recommendations of the J&K PSC.
2. That the arrangement shall be purely temporary till the permanent incumbents/selection list of Principals is received from the J&K PSC.
3. That the arrangement shall be subject to the outcome of Writ Petition(s), if any, pending consideration before any competent Court(s) of law.

4. That the arrangement shall be reversible and shall automatically cease upon repatriation, joining, or posting of regular Principals in the concerned Institutions, without any prior notice.
5. That the arrangement shall also be reversible in case of receipt of any adverse report from any Investigating Agency(s) against any Faculty Member.
