**Subject: Grant of ex-gratia relief of the persons affected by Law and Order disturbances**

**Government Order No.: 1716-JK(GAD) of 2025**  
**Dated: 03.12.2025**

In amplification of previous Orders issued on the subject, a consolidated set of instructions, governing sanctioning of ex-gratia relief under Security Related Expenditure (SRE), is hereby notified as under:

**A. Ex-gratia relief for Magistrates and Police Personnel:**

| S. No. | Category                     | Amount     |

| 1.     | For Death (Magistrates)      | ₹2.00 Lakh |
| 2.     | For Death (Police Personnel) | ₹5.00 Lakh |
| 3.     | For Death (SPO)              | ₹5.00 Lakh |
| 4.     | For Death (Ex Servicemen)    | ₹2.00 Lakh |
| 5.     | For Permanent disability     | ₹0.75 Lakh |
| 6.     | For Partial disability       | ₹0.10 Lakh |

**B. Ex-gratia relief for Personnel of CAPF:**

| 7.    | Injury (hospitalization less than 24 hrs)                    | ₹ 0.01 Lakh |

| 1.    | Damage by a Bomb Blast or any other kind of sabotage           | 50% of the loss or ₹1 lakh which ever is less.<br><br>₹10 lakh or actual damage which ever is less (₹7 lakh (Immovable Property) + ₹ 3 lakh (Movable Property)) |
| 2.    | Damage on IB/LOC due to shelling/firing from across the border | 50% of the loss or ₹ 1 lakh which ever is less.                                                                                                                 |

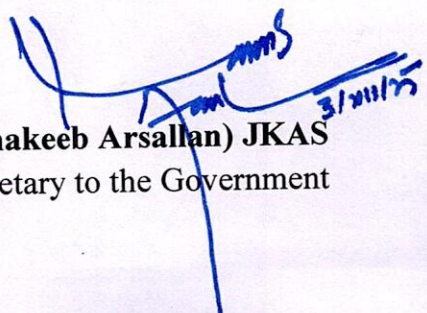
