Administrative Approval is hereby accorded to the "Permanent restoration of damaged approach of 4th Tawi Bridge", for an estimated cost of **Rs.1975.16 Lakh**, to be executed under Capex Budget - Construction of Roads (MH- 5054 & SH-3342).

The Administrative Approval accorded is subject to the fulfillment of following conditions:

1. That the work shall be executed after observing all Codal/procedural formalities as laid down in GFR 2017/Manual for procurement of Works/Bridge Manual and the instructions issued by Finance Department from time to time.
2. That the Administrative Approval shall not be construed as any rate approval to the project/detailed estimates.
3. All the conditions as laid down in the Technically vetted estimates by the Engineer In Chief Shall be adhered strictly.
4. That the project shall be designed as per latest relevant I.S. Codes and specifications of MoRTH/PWD Engineering Manual 2020/CPWD and as per J&K Bridge Manual. The same are authenticated and proof checked by the competent authority (IIT/NIT/DIQC) before taking up execution in hand.
5. That the rates for the items not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.

6. That the lump-sum provisions, either in terms of percentage as made for certain components of each DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
7. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD schedule of rates for e-tendering purpose of each project.
8. The detailed estimate of works shall be technically sanctioned by the competent authority.
9. It must be ensured that there shall be no multi source funding or overlapping of schemes under different programmes.
10. E-tendering mode is followed for fixation of the award of contract for execution of the projects. Fragmentation of project while tendering is not allowed.
11. That the NOCs from all regulatory authorities are sought before the commencement of works, besides all the environmental norms are followed in letter and spirit.
12. That the Electrical/Mechanical/Electronic Components are authenticated and technically vetted by the competent authorities of relevant field.
13. That the standard specifications are followed as per CPWD, NBC and 1.5 standards.
14. That the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE for the type of structures, proposed in the DPR, are followed and adopted for the execution of the works.
15. That the Technical Vetting is exclusively for the purpose of Accord of Administrative Approval and shall not be construed as any rate approval to the projects or any approval for inclusion in the plan.
16. That the concerned Executive Engineer shall maintain pre and post work video/ photographic evidence in case of each work.
17. Design of the Work be designed in consultation with NHIDCL/ Jammu Smart City Ltd.

It is further ordered that the Committee constituted vide Government order No. 373-PW(R&B) of 2025 Dated: 15.12.2025 shall Supervise of all works related to the strengthening and Flood resilience of the 4th Tawi bridge near Bhagwati Nagar.
