Subject: Celebrations of National Voters' Day (NVD) on 25th January - 2026.

The National Voters' Day is being celebrated across the country on 25th January, 2026, with the theme of "**My India, My Vote**"

In order to ensure befitting celebrations on the occasion, Election Commission of India has desired that necessary instructions be issued to schools and educational institutions for organizing events such as debates, discussions, competitions (drawing, skit, song, painting, essay etc) on the above mentioned theme. The Commission has directed that events shall be organized either **at 11:00 a.m.** or at any suitable time during the day, on **25th January, 2026 (Sunday) or 23rd January, 2026 (Friday) (in the States/UTs where 24th and 25th January are non-working days)**. It has been further directed that the officers/officials of Government Departments/PSUs/Corporations and offices in the Union territory shall be administered the **NVD pledge** on the Day (**Copy enclosed**) and photographs of these events be uploaded using hashtag #NVD2026, on their respective social media handles or website(s) of these Departments/PSUs/ Corporations. Besides, the logo for National Voters' Day, which reinforces importance of voting, may also be suitably utilized on official stationery, merchandise, websites etc for the event.

Accordingly, it is impressed upon all Administrative Secretaries, Divisional Commissioner(s), Deputy Commissioner(s)/Heads of the Departments/ Managing Directors of all PSUs/Corporations to strictly comply with the instructions of the Election Commission of India issued in terms of communication No.491/SVEEP-I/NVD/2025 dated: 15th January, 2026 duly forwarded by office of Chief Electoral Officer, J&K in terms of communication No. CEO/SVEEP/NVD/2025/5810-17 dated: 16th January, 2026 (**copy enclosed**) and ensure appropriate National Voters' Day Celebrations across Union territory of Jammu and Kashmir.




